Approval of the Agreements for the Sheriff to Retire Two Canines in the Sheriff's Canine Unit

#### DISCUSSION:

It has been the Department's practice to retire canines to their handlers when they reach an age or condition where they can no longer be of service. There is a need to retire two (2) of the Sheriff's current canines.

Canine Anna is a 10 year old Black Labrador breed that began service with the Sheriff's Department in March 2005. Anna's handler, Criminal Investigator Dustin Bruley, left the Sheriff's Department for a new career at the District Attorney's office in March 2014. A new handler for Anna would require a selection process, extensive training process and re-certification that would extend approximately for one year. This would make Anna 11 years old which is typically the age of retirement for the canines. To extend Anna's career this additional year would not be efficient.

During Anna's years of service she located 3,678 pounds of marijuana, 491 pounds of methamphetamine, 11 pounds of cocaine and 20 pounds of heroin. The total amount of money seized during Anna's years of service was \$2,421,608 for a yearly average of \$242,160.

Canine Gizmo is a 9 year old Belgian Malinois breed that began service with the Sheriff's Department in December 2007. Gizmo was recently evaluated and needs to be retired at age 9 due to age and health conditions. During Gizmo's years of service he has had numerous apprehensions and assists; the most notable was in 2012 when he located a not only a parolee at large but also another person who was violating probation. Both were taken into custody.

The Sheriff's Department desires to retire both canine Anna and canine Gizmo from law enforcement service and enter into retirement contracts with their current handlers, Criminal Investigator Bruley and Deputy Condit. The Department would like to retire the canine's to their current handler so the dogs may live out their remaining years with someone who has and will continue to care for them.

This item is being submitted to the Board of Supervisors to approve the contracts necessary to implement the above actions.

This AGREEMENT, made and entered into in the County of Stanislaus, State of California, this 15th day of July, 2014, by and between the County of Stanislaus, hereinafter referred to as "COUNTY", and Dustin Bruley, hereinafter referred to as "OWNER".
