SUBJECT:

Approval for the Stanislaus County Sheriff to Purchase a MX-10 Surveillance Camera System for the Cessna 206 Craft

STAFF RECOMMENDATIONS:

- 1. Authorize the Sheriff to purchase an MX-10 Surveillance Camera System and install the system on the Departments Cessna 206 Aircraft (Tail # N3501R).
- 2. Authorize the Sheriff to accept contributions from Central Valley High Intensity Drug Traffic Area (HIDTA) and Stanislaus Drug Enforcement Agency to go towards the purchase of this MX-10 Surveillance System.
- 3. Direct the Auditor-Controller to increase estimated revenue by \$ 200,000 and appropriations by \$763,840 in the Sheriff - CalMMET budget as detailed in the Budget Journal Form.

#### FISCAL IMPACT:

The MX-10 Camera system is available with many features which can cause the price to fluctuate greatly depending on which features are necessary for the proposed use of the equipment. The configuration that is needed to continue to carryout surveillance of multi-agency drug investigations will cost \$414,060 for the equipment and another \$349,780 for installation and labor for a total of \$763,840.

Approval for the Stanislaus County Sheriff to Purchase a MX-10 Surveillance Camera System for the Cessna 206 Craft

## FISCAL IMPACT: (continued from page 1)

The Sheriff has reached out to some of the partners in law enforcement for financial assistance in making this purchase and has received commitments from the Stanislaus Drug Enforcement Agency (SDEA) for \$100,000, Stanislaus Drug Enforcement Agency (SDEA/High Intensity Drug Traffic Area (HIDTA) \$50,000, and High Intensity Drug Traffic Area (HIDTA) \$50,000, leaving \$563,840 needed to fund the purchase of the Camera. Available fund balance in the Sheriff - CalMMET budget will cover the entire \$563,840. There is no General Fund Impact.

As of December 9, 2014 the Department has identified \$599,050 in fund balance. It is anticipated that the Department's estimated revenue will come in higher and expenditures will be less than appropriations, a change from the 2014-2015 Adopted Final Budget that frees up Fund Balance to help cover the purchase of the camera. With the use of \$563,840 of fund balance, the Department anticipates \$35,210 in fund balance at year end.

## DISCUSSION:

The California Multi-Jurisdiction Methamphetamine Enforcement Team (Cal-MMET) was initiated on September 1, 2001 to target mid to high level methamphetamine manufacturers and distributors operating within the state of California. The Cal-MMET team originally funded individual counties with a demonstrated Methamphetamine problem and granted each municipality enough funds to purchase a Cessna 206 plane with a long distance surveillance system and the necessary related equipment. Since the initial funding the program has gone through several changes and is now open to all 58 counties in the state of California and functions more as an annual funding source with record keeping requirements but no reporting requirements at this time.

In 2001 Stanislaus County through the Sheriff's Department was awarded a grant from the California Multi-Jurisdictional Methamphetamine Enforcement Team (Cal-MMET) program to purchase a Cessna 206 outfitted with a high altitude surveillance camera with thermal imaging capabilities and all of the equipment necessary to view the images during flight and record the video for review later. The current surveillance equipment has been heavily used as an investigative and surveillance tool increasingly since 2001.

This camera has become an invaluable tool for the Sheriffs Department as well as the Stanislaus Drug Enforcement Agency who regularly partners with the Sheriff to conduct surveillance and investigations into narcotic related crimes including selling and transportation of methamphetamine. Due to the age of the equipment and the heavy use by the narcotics team and the support to other allied agencies the current camera has ceased to operate reliably. The camera often shuts down or becomes inoperable during flights which limit the capabilities of the investigators at a critical point in the investigation. The Department has kept the equipment functioning by repairing and replacing parts as problems arise. However the original manufacturer of the equipment no longer supports the model of equipment used and the Department no longer has an option to repair the current camera. When this piece of equipment ceases to function, the Department will no longer have equipment capable of long distance surveillance from the air.

The Department is proposing to purchase a Wescam MX-10 Multi-Sensor, Multi-Spectral Imaging System manufactured by L3 systems. The MX-10 system is a lightweight high definition camera system which minimizes drag on the plane and maximizes the surveillance capabilities of the operator. It contains several sensors which allow it to function in all conditions including low light, night and foggy conditions. The unit also has GPS capabilities that allow it to automatically find a specific set of coordinates or follow a car without the operator having to move the camera. When necessary the operator can manually control the unit with a small hand controller which fits easily into the confines of a small plane. Due to the unique characteristics of this system and the requirements of the Sheriff's Department, General Services Agency has declared this to be a sole source purchase.

The purchase of a new surveillance camera will allow the Sheriff's Department to continue investigations which require an element of long range surveillance that is undetectable by the person/activity being watched. The proposed camera will offer more flexibility that the current model because if proper housing is installed on other aircraft the camera can be quickly moved from one aircraft to another before deployment which will allow the Department to provide a much more dynamic response capability in the future.

Since so many cooperating agencies have a vested interest in having a piece of equipment capable of long distance surveillance the Department has been able to secure financing for the unit and its installation from multiple funding sources resulting in no general fund costs associated with this project. SDEA and Central Valley HIDTA have both agreed to contribute funding and the Sheriff's Department will use fund balance from the Cal-MMET program which has been generated through cost savings in the unit over previous years.

Each of these funding sources are appropriate for this use because the equipment will be primarily used for the spotting, marking, surveillance and investigation of narcotics and narcotic related offenses taking place within Stanislaus County which lies in the jurisdiction of Central Valley HIDTA, Stanislaus Drug Enforcement Agency and the Stanislaus County Sheriff's Department.

#### POLICY ISSUES:

Approval of this Agenda Item supports the Board of Supervisors priorities of a Safe Community and Effective Partnerships. This Camera system is a primary surveillance tool used in the investigation of many cases involving the trafficking of methamphetamine in and out of the state. These cases generally require the cooperation of multiple law enforcement agencies from local, state and federal jurisdictions.

There are no staffing impacts associated with this equipment purchase.

#### JUSTIFICATION: (Attach additional sheets, if necessary)

The Wescam MX-10 camera is a state of the art tactical surveillance system which meets the needs of the Sheriff's Department and has imaging capabilities in Infrared, Cotor HD and Electron-Multiplied CCD which ellows It to take highly detailed surveillance in all weather conditions. It has GPS capabilities which allow it to stay focused on a single location or track a moving target automatically so operator error is removed from the surveillance process. When necessary the operator can manually control the unit with a small hand controller which fils easily into the confines of a small plane. Other camara systems with similar capabilities were evaluated, the Controp DSP-1 provides many of the same options as the WESCAM however the camera is 40% heavier and has a diameter which is 27% longer than the WESCAM. The GSS S516 RetinEve was also evaluated but it is 85% heavier and has a 56% larger diameter than the WESCAM. These additional pounds cause every flight to be more expensive and the larger diameter of the camera creates significant drag on a small plane such as a Cessna 206.

#### 21.MICROWAVE EQUIPMENT

The microwave equipment that forms the basis of this proposal shall transmit and receive over 10 customer selected channels within the band of 1.99 to 2.5GHz U.S. FCC B.A.S. channels 1 to 10 (and offsets). The Customer may alternatively select the 2.3 to 2.7GHz band, however, price and delivery are subject to adjustment. Purchaser without Wescam's prior written permission;

use the Training Material and related materials to reverse engineer, decompile or disassemble any iv) Wescam products;

v) use or permit use of the Training Materials or related materials by any person in any way that would constitute a breach of this contract or applicable laws.

Excusable Delays: Wescam shall not be liable to the Purchaser for any loss, damage, delay in the work or non-7 performance of any contractual obligation caused by fire, flood, strike, walk-out, labour difficulties, delay of transportation, unusually severe weather, freight embargo, epidemic, the act of government or an act of God or public enemies or by any other cause which is beyond Wescam's reasonable control, and provided that notice is given thereof to the Purchaser at the earliest reasonable date. In the event of delay resulting from any of the above, the delivery schedule and contract price shall be equitably adjusted.

Termination: The Purchaser may terminate all or any portion of the work hereunder at its convenience upon 30 days 8 written notice to Wescam.
