This notice is to notify you of an extension of the above-referenced Notice that you previously received, which originally was issued in October 2014, regarding American Medical Response's ("AMR") intent to significantly reduce staffing at the AMR Modesto office, located at 4701 Stoddard Road, Modesto, CA 95356. In that Notice, it was explained that permanent layoffs would be conducted in two stages, with one group of employees being laid off on December 31, 2014 and a second group being laid off on March 2, 2015. A listing of the affected employees was provided with that Notice.

In the October 2014 notice, it was noted that, although certain aspects of AMR's business would be moved to Centrex, that would not change the planned, permanent closure of the Modesto office.

Due to changing business needs and operational concerns, Centrex has decided that the Modesto office will need to remain open until December 31, 2015, and that the Company will need to retain the services of certain employees at the facility until that date. However, the entire Modesto office will close permanently on December 31, 2015, or on a date within the fourteen-day period immediately after December 31, 2015, and that date also will be the date of separation of employment for the affected employees.
