Dear Ms. Carrington and Members of the Stanislaus County Board of Supervisors,

Emanuel Medical Center, Inc. hereby gives notice, pursuant to California Health and Safety Code Section 1255.25, of its intent to close the Emanuel Family Practice, located at 1010 West Las Palmas Avenue, Patterson, CA 95363 and Emanuel Family Practice, located at 2240 West Monte Vista Avenue, Turlock, CA 95382 on or about May 8, 2015. Concurrent with this notice, Emanuel Medical Center, Inc. is posting notice of these service closures and other public information as detailed in Section 1255.25 at the entrance of both clinics. A copy of the posted notice is attached.

The reason for the closure of the clinics and the termination of services thereby is that the sole primary care physician available to provide services at both clinics is departing from the practice and will no longer be available to provide services. Further, Emanuel Medical Center is unable to find a replacement for this physician. Therefore, the hospital cannot continue the services or programs currently provided by the clinics.
