#### **DISCUSSION:**

The Department of Environmental Resources (Department) charges fees for services it provides in the program areas of Code Enforcement, Environmental Health, Hazardous Materials, Landfill, Milk and Dairy, and Solid Waste. State law mandates that fees charged for services cannot exceed actual costs and must be used to cover the costs of implementing the programs.

Annually, in preparation for the Proposed Budget, the Department evaluates the program costs and the fees associated with programs administered. This process includes the consideration of new or additional fees, where appropriate, as well as modifications to existing fees in order to cover the program costs. The recently conducted fee survey of comparable counties in the State found that proposed fees are in-line with other counties of comparable demographics.

This year the Department is proposing the creation of new fees for implementation of the revised Groundwater Ordinance, Environmental Health food permit replacement copies, and Temporary Food Facility late registrations. Modifications to existing fees include increases to: Employee Camps, Landfill tire, large dead animal, and mattress disposal fees, Underground Storage Tanks, the Medical Waste Program, the Farm Disclosure Program, and Aboveground Storage Tanks. The Department is proposing a decrease to the tipping fee for ash from the Waste-to-Energy (WTE) facility. Additionally, the following fees are proposed to be eliminated: the Medical Waste Program Limited Quantity Hauling Exemption fee and the Landfill temporary tipping fee roll-back that was implemented in 2014. There are no proposed fee changes for the Solid Waste, Code Enforcement, or Milk and Dairy Divisions. The proposed fee schedule is included as Attachment A. The details on the recommended changes are as follows:

#### Groundwater Ordinance Fees

The Stanislaus County Groundwater Ordinance (GWO) was adopted on October 29, 2013, and was later revised on November 25, 2014. The County requires professional consultant services to assist the Department in the implementation of the GWO permitting requirements. The costs for these services, as well as filing fees and additional staff review time, will result in increased processing costs related to implementation of the revised GWO. These costs are reflected in the proposed fees table in three ways. The first relates to capturing the additional staff time needed to review permit applications and to prepare any necessary environmental documentation. Staff proposes to capture these costs by charging a fee equal to the actual hours expended multiplied by the staff weighted labor rate (WLR). Staff will develop a time tracking system for each well construction permit application subject to the new requirements. In addition, the fees will include the actual and necessary costs incurred by the county for consultants related to the permitting process as well as any necessary filing fees.

The proposed fee schedule offers a Groundwater Ordinance Permit Issuance Appeal Fee for both "Ag/Irrigation" and "Private (all except Ag/Irrigation)". For clarification purposes, the former "Groundwater Mining and Export Prevention Ordinance" has now been replaced with the title of "Groundwater Ordinance." There are no changes in the fee structure.

### Food Program Permit Replacement and Community Event Organizer Late Registration Fees

The Environmental Health division is responsible for enforcing the laws set forth in the California Retail Food Code (CRFC), an excerpt of the California Health and Safety Code. This includes routine inspections of approximately 2,000 food facilities throughout Stanislaus County. The CRFC states a food facility shall not be open for business without a valid permit. Furthermore, the permit shall be posted in a conspicuous location within the food facility. While each food facility is inspected for compliance a minimum of once per year, a permit to operate is re-issued every five years. The Department receives several requests per year for replacement permits and is proposing to establish a new fee of \$25 to recover the cost of preparing permits that are less than five years old.

The CRFC also establishes regulations for the operation of Temporary Food Facilities (TFF). A TFF is defined as a "food facility approved by the enforcement officer that operates at a fixed location for the duration of an approved community event or at a swap meet only as a part of the community event or swap meet." Permit applications are required to be submitted to the Department at least two weeks prior to operation of any food facility. Current TFF fees are based on the number of TFFs per event and range from \$211-\$1,114. During calendar year 2014, Environmental Health permitted 93 community events. Of the 93 events, 22 community event organizers submitted TFF applications less than two weeks prior to the opening date of the event. The Department is now proposing to establish a new fee for applications that are submitted within two weeks of the opening date of the event. The additional fee will be based on the number of TFFs per event and will equate to 50% of the original TFF fee. The new fee will be billed to the community event if the organizer application packet is received within two weeks of the opening date of the event. This fee will recover the costs of expediting the permit application process.

#### Employee Camp Fees

The California Department of Housing and Community Development (HCD) is responsible for enforcing the laws set forth in The Employee Housing Act; an excerpt of the California Health and Safety Code. Upon approval from HCD, any city or county may assume responsibility of the Employee Housing Act. The following city and counties have accepted regulatory authority from HCD: Gonzales, Kern, Monterey, Napa, Sacramento, San Joaquin, San Mateo, Santa Cruz, Tulare, and Stanislaus. In Stanislaus County, the Environmental Health division is responsible for enforcing the laws set forth in The Employee Housing Act.

Effective October 1, 2009, Assembly Bill X4 12 increased HCD-regulated employee camp fees for Employee Housing from \$35 to \$200. The legislation also increased the fee for each employee from \$12 to \$27. Of the ten jurisdictions regulating The Employee Housing Act, seven have raised fees to align with the HCD increase. Current Department fees do not cover the costs of enforcement, which provides service and regulatory authority that is equivalent to HCD. The proposed fee increases will align Department fees with HCD. The new fees will increase revenue by \$2,020 lowering the program shortfall to \$4,108.

#### Hazardous Materials

On January 1, 1997, Stanislaus County was certified by the California Environmental Protection Agency (Cal EPA) to be the Certified Unified Program Agency (CUPA) for all Stanislaus County. In its capacity as a CUPA, the County, by and through the Hazardous Materials Division of the Department of Environmental Resources, administers the following program, pursuant to the authorities granted by the California Health and Safety Code, Section 25404:

- Hazardous Materials Business Plan Program
- California Accidental Release Prevention Program
- Hazardous Waste Generator Program
- Tiered Permitting Program
- Underground Storage Tank Program (UST)
- Aboveground Petroleum Storage Tank Program (AGT)
- Medical Waste Management Program

CUPA staff spent the majority of their time inspecting facilities that fall under the CUPA programs. CUPA staff also performs other non-inspection duties, such as responding to and addressing complaints, plan reviews, consultations, follow-ups, legal action/enforcement, providing education and training workshops, and responding to emergency calls.

Based on staff's evaluation of the current CUPA fees versus projected expenses of the CUPA in Fiscal Year 2014-2015, staff recommends the revision of the CUPA fees for the following programs:

- Farms Disclosure Program (which is part of the Business Plan Program)
- UST
- AGT
- Medical Waste

The projected costs to run the above CUPA programs total approximately \$342,379. Revenues generated by existing fees for these programs are anticipated to be approximately \$218,189, which leaves a deficit of \$124,190. If fee increases are adjusted as requested, the program revenues would increase for each of the programs as follows: Underground Storage Tank Program, \$41,830; Medical Waste Program, \$6,783; Farm Hazardous Materials Business Plan, \$3,101; and Aboveground Petroleum Storage Tank Program, \$5,606. The total of this increased revenue is estimated to be \$57,320. The proposal is to gradually increase fees over the next few years to fully eliminate the deficit.

#### <u>Underground Storage Tank Program</u>

Hazardous Materials staff is responsible for the issuance of UST operating permits for facilities that store hazardous materials underground. This requires the on-site inspections of all UST facilities within the County as well as reviewing facility submittals into the California Electronic

Reporting System (CERS) data base for accuracy. The Board last amended the current UST Program fees in 2008.

This year's fee proposal will include a change in the fee structure for all permitted facilities. In addition to the permit fee currently charged, there will also be a separate per tank fee. Regulatory requirement changes, such as inspector training and certification, enhanced leak detection requirements, and the CERS implementation, have increased staff time within the program causing an increase in program costs. In order to cover the increased cost to run the UST program, staff is proposing to charge a flat rate permit fee using the lowest rate of \$522 and add a per tank fee of \$100. This type of fee structure is consistent with many of our comparable counties.

The projected costs associated with implementing the program is \$172,748. The projected revenue at the current fee is \$132,834, leaving a deficit of \$39,914. The proposed fees would produce additional estimated revenue of approximately \$41,830 for this program, which will cover the current deficit.

#### Medical Waste Program

The program staff regulates healthcare facilities, companies, and private citizens that produce, treat, transport, or dispose of infectious medical waste. Medical waste consists of sharps (needles & syringes), bandages, and other items contaminated by body fluids. The Board last amended the current Medical Waste Program fees in 2008.

For the Medical Waste Program, the Limited Quantity Hauling Exemption fee is being eliminated due to a revision of the Medical Waste Management Act. Medical waste generating facilities may now transport up to 35.2 pounds of medical waste, pursuant to the Materials of Trade Exemption contained in Section 173.6 of Title 49 of the Code of Federal Regulations. Transporting in excess of 35.2 pounds of Medical Waste requires a Hazardous Waste endorsement on a commercial vehicle license, so a fee from the Department will no longer be required.

The projected costs associated with implementing this program is \$61,161. The projected revenue at the current fee is \$50,525, leaving a deficit of \$10,636. Staff's recommendation is to increase the fees for this program by 10%. The proposed fees would produce additional estimated revenue of approximately \$6,783 for this program. The proposal is to gradually increase fees over the next few years to fully eliminate the deficit.

#### Farm Disclosure Program

The Farm Disclosure Program regulates farming facilities that store hazardous materials in quantities greater than 55 gallons of a liquid, 200 cubic feet of a gas, or 500 pounds of a solid. Recent regulatory requirement changes, such as the CERS requirements, have increased staff time within the program. The Board has not amended the Farm Disclosure Program fees since they were implemented back in 1996.

The projected costs associated with implementing the program is \$39,320. The projected revenue at the current fee is \$12,404, leaving a deficit of \$26,916. Staff's recommendation is to increase the fees for this program by 25%. The proposed fee increase would produce additional estimated revenue of approximately \$3,101 for this program. The proposal is to gradually increase fees over the next few years to fully eliminate the deficit.

#### Aboveground Petroleum Storage Tank Program

The Aboveground Petroleum Storage Tank Program regulates facilities that store 1,320 gallons (or greater) of petroleum products in aboveground tanks. Recent inspector training, regulatory requirement changes, such as the re-writing of the Aboveground Petroleum Storage Tank laws and the CERS requirements, have increased staff time within the program. The Board approved the current Aboveground Petroleum Storage Tank Program fees in 2010.

The projected costs associated with implementing the program is \$69,150. The projected revenue at the current fee is \$22,426, leaving a deficit of \$46,724. The staff recommendation is to increase the fees for this program by 25%. The proposed fees would produce additional estimated revenue of approximately \$5,606 for this program. The proposal is to gradually increase fees over the next few years to fully eliminate the deficit.

#### Landfill Fees

#### Ash Tipping Fee

On June 26, 2012, the Board of Supervisors approved the Amended and Restated Service Agreement with Covanta Stanislaus, Inc., for the operation of the waste-to-energy facility. As a result, ash tipping fees were raised in Fiscal Year 2012-2013 by \$10 per ton. This increase was necessary in order to cover future ash monocell development/construction costs, as well as the post-closure obligations at the Geer Road Landfill. Also included in the new Service Agreement was a clause that would adjust the tipping fee each July 1<sup>st</sup> based on the Consumer Price Index (CPI), "Urban Wage Earners and Clerical Workers, All items, West-Size B/C." The CPI will decrease the ash tipping fee by 0.39% for Fiscal Year 2015-2016. This will decrease the current \$26.63 per ton tipping fee for ash to \$26.53 per ton. The estimated decrease in revenue from this change is approximately \$7,500.

#### Tire, Mattress, and Large Dead Animal Fees

Fink Road Landfill provides services as a waste tire collector for Stanislaus County residents and businesses. The Landfill presently maintains two 45 foot trailers onsite for the removal of waste tires. The trailers are owned by Golden By-Products (current vendor). The vendor's February 2015 billing statement reflected a charge of \$975 for the removal of waste tires for each fully loaded trailer. The vendor has since notified the Landfill that they are increasing the cost per trailer to \$2,200 which is a \$1,225 increase or 225%.

As a result, staff is proposing an increase to the waste tire fees to cover this cost for all waste tire types and sizes, including the per ton bulk-rate for waste tires. The following are the

proposed price increases: motorcycle/car/pick-up tires from \$1 each to \$2.50 each; diesel truck tires from \$6.50 each to \$15 each; tractor tires from \$10 each to \$25 each; loader tires from \$50 each to \$110 each; earthmover tires from \$100 each to \$225 each; and bulk tires from \$100 per ton to \$225 per ton. This increase is necessary for the following reasons: the cost to dispose of waste tires has increased significantly, the fees for some tires (passenger car tires) have not been increased in a decade or more, the current per-ton cost for bulk tires is unsustainable for program cost recovery, and these increases are essential for program sustainability. The estimated revenue increase will be approximately \$13,475.

Staff is proposing an increase to the Landfill's dead horse and large animal disposal fee from \$50 per animal to \$100 per animal in order to cover the costs associated with collection and disposal. In addition, the large dead animal category is being expanded to include llamas, donkeys, and mules. The proposed price increase is essential due to increases in labor costs, fuel, and equipment, because special handling is required in the disposal of large dead animals. The estimated revenue increase will be approximately \$900.

The Landfill also provides services as a waste mattress collector for Stanislaus County residents and businesses. The Landfill presently maintains one 45 foot trailer onsite for removal of waste mattresses. The trailer is owned by DR3 Mattress Recycling (current vendor). The current vendor charges \$300 for removal of the trailer (exchange one empty trailer for one full trailer) plus a \$6 per mattress fee. The current average per mattress cost to the County equates to approximately \$7.71 per mattress.

In order to control the costs in this program, the Landfill historically used Alternative Work Program (AWP) personnel. Over the last few years, the participants in the AWP Program have slowly dwindled to zero. Because of this, the Landfill currently must use full and part-time employees to load these mattresses into the empty trailers for disposal. As a result, staff is proposing an increase to its waste mattress disposal fee, from \$8 per unit to \$10 per unit, in order to cover the costs of the program. This proposal intends to cover the overall increase in labor costs associated with the disposal of mattress and box spring wastes, and futons are proposed to be added to this category as well. The waste mattress fee is estimated to increase revenue by \$4,308, which is essential to program sustainability.

#### Normal Refuse Tipping Fees

In 2014, the Board approved a temporary tipping fee price roll-back of \$3 per ton, from \$33 to \$30 per ton, for a 90-day trial period beginning July 1, 2014. This was implemented to determine whether sufficient additional tonnage might be received to off-set the revenue loss. At the end of the 90-day trial period, staff determined that this did not provide sufficient incentive to our local waste haulers to bring additional tonnage; therefore, the temporary price roll-back was allowed to expire on September 30, 2014. At this time staff recommends eliminating this from the fee structure.

#### Public Meetings

On March 17, 2015, the Department held two public meetings (Attachment B) to discuss the proposed new fees, adjusted fees and the eliminated fees. Information about the workshop was disseminated through the Department's normal dissemination process via email and postal service mailed to all parties affected or potentially affected by the fees. In addition, information regarding the proposed fee workshop was published in the Modesto Bee and posted on the Department's web site. The proposed fees are posted on the Department's website. The overall feedback from the workshop participants was favorable to all the proposed new and amended fees.

#### Public Hearing

Prior to levying a new fee or amending an existing fee, the County is required by Government Code Section 54985 et seq., to hold a scheduled public hearing as part of a regularly scheduled meeting of the Board of Supervisors. Department staff recommends that the Board schedule a public hearing for April 28, 2015, at 9:05 a.m., to introduce and waive the first readings of modified Ordinance to establish new and amend the existing fees of the Department of Environmental Resources. If approved, these fee changes for Environmental Resources will correspond with Fiscal Year 2015-2016, and will become effective on June 18, 2015, with the exception of the Landfill fees which will become effective on July 1, 2015. The fee changes are summarized in the tables below:

Subject: Temporary Food Facility Fees

A Temporary Food Facility is defined as a "food facility approved by the enforcement officer that operates at a fixed location for the duration of an approved community event or at a swap meet only as a part of the community event or a swap meet." Permit applications for Temporary Food Facilities are required to be submitted at least two weeks before the date of the event, by the community event organizer. This allows Environmental Health staff sufficient time to process the applications. Often, however, applications are submitted less than two weeks prior to the opening date of the event which presents a hardship on staffing resources. In an effort to curtail the submittal of late applications, a Late Registration Fee is being proposed.

If approved by the Board of Supervisors, this would constitute a new fee that would be billed to the community event organizer. If you would like to have input into this recommendation, please join us for the fee workshop as listed on the reverse side of this page.
