



NOTICE OF LANDOWNER DISTRICT ELECTION

NOTICE IS HEREBY GIVEN that a landowner District Election will be held in the Orestimba Flood Control District on November 3, 2015. All offices are for four years unless otherwise stated.

OFFICE

- 1 Director, Area 2, long term
- 1 Director, Area 4, long term
- 1 Director, Area 5, long term

The qualifications of a nominee and of an elective officer of the district are as follows: Each director shall be a holder of title to land within the district.

Official nominating papers for eligible candidates desiring to file for any of the elective offices may be obtained from the Secretary of the district at: 22130 River Road, Crows Landing

Forms for declaring candidacy shall be available commencing on July 13, 2015, before the election and shall be filed with the Secretary of the district at the above address no later than August 7, 2015 before the election.

Appointments to each elective office will be made in the event there are no nominees or an insufficient number of nominees for such office and a petition for an election is not filed within the time period prescribed by law. Appointments will be made pursuant to 10515 of the elections code.

The Candidate is to pay for publication of a Candidate's Statement pursuant to Elections Code Section 13307.

The polls will be open election day, November 3, 2015 from 7:00 a.m. to 8:00 p.m.
