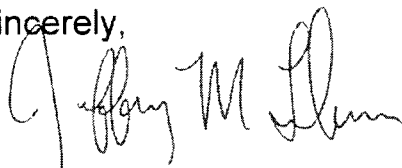
Dear Ms. Ferraro Tallman:
