Re: Reduction In Force

Dear Sirs and Madams,

This letter is to advise the agencies identified above that Sutter Central Valley Hospitals dba Memorial Medical Center ("MMC"), a California nonprofit public benefit corporation, unfortunately finds it necessary to eliminate positions and plans to terminate the employment of a number of employees, which may entail a "layoff" under WARN and/ or California's Worker Adjustment and Retraining Notification requirements (pursuant to California Labor Code §§ 1400-1408).

The reductions in staff will occur at the following sites of employment:

It is anticipated that these will be position eliminations and that employee separations are expected to commence and occur on or about April 25, 2016. These position eliminations will affect a total of approximately 96 employees in various positions in this facility, as identified by job titles below. Please note that MMC expects that it will offer employment in new positions to some employees whose positions are being eliminated. MMC employees will be notified by MMC if they are offered a new position with MMC.
