On behalf of CST California Stations, Inc. (the "Company"), I am sending this letter to provide voluntary notice consistent with the Worker Adjustment and Retraining Notification Act ("WARN") (29 U.S.C. Sections 2101 et seq.) and the California WARN Act (CA Labor Code Sections 1400 et seq.) and to give as much advance notice to you as possible.

In connection with a sale of the Company's assets, the Company will be permanently closing the entirety of its California operations, including all "Corner Store" facilities in the employment sites listed on Exhibit 1.

While an exact date has not yet been established for these closures, it is anticipated that the employment of the affected employees in these employment sites will be terminated on July 5, 2016 or within the fourteen days thereafter. The purchaser of the Company's assets has requested the Company to continue to operate certain yet-to-be identified facilities past this time, in which case employment terminations may occur at such later date.

A list of the job titles of those employees who will be affected, complete with an indication of the number of individuals classified under each such job title, is enclosed. None of the displaced employees will possess bumping rights. None of the affected employees belong to a bargaining unit for purposes of representation.
