Authorization to Record a Certificate of Cancellation of a 607.31-Acre Portion of Williamson Act Contract No. 1971-0101, Located East of Sullivan Road, and Bisected by Pete Miller Road, West of Interstate 5, in the Newman Area

STAFF RECOMMENDATION:

- 1. Find that the condition and contingencies of the Tentative Certificate of Cancellation of a 607.31-acre portion of Williamson Act Contract No. 1971-0101, (original contract name: Simon Newman Company), located east of Sullivan Road, and bisected by Pete Miller Road, west of Interstate 5, in the Newman area, have been satisfied.
- 2. Direct the Clerk of the Board to execute and record the Certificate of Cancellation.

DISCUSSION:

On April 16, 2019, the Board of Supervisors granted tentative approval of a petition to cancel a 607.31-acre portion of Williamson Act Contract No. 1971-0101 for property owned by the Robert Houret Construction, Co. On April 29, 2019, a Certificate of Tentative Cancellation was recorded as Document Number 2019-0025829-00, Stanislaus County records. The certificate specified that the condition and contingency to be satisfied was the payment of the cancellation fee of \$85,500. Said payment was made to Stanislaus County on November 22, 2019 (see Attachment 1).

State law requires the landowner to notify the County Board of Supervisors when they have complied with the conditions of tentative cancellation; and the landowner has done so through payment of the cancellation fee. A Certificate of Cancellation is to be executed by the Board of Supervisors and recorded with the County Clerk-Recorder. Within 30 days of the execution of the Certificate of Cancellation by the Board of Supervisors, the County Treasurer shall transfer the entire cancellation fee amount to the State Controller.

POLICY ISSUE:

Government Code Section 51283.4(b) provides that the notification, execution, and recordation of a Certificate of Cancellation takes place as outlined above. This is the final step in processing the Williamson Act cancellation tentatively approved as a part of Williamson Act Contract Cancellation and Use Permit application number PLN2015-0081 – Sullivan Road Solar approved by the Board of Supervisors on April 16, 2019.

FISCAL IMPACT:

There are no fiscal impacts associated with this item. Payment in the amount of \$85,500 was received by Stanislaus County on November 22, 2019, and will be forwarded to the State of California as required by State and local regulations.

BOARD OF SUPERVISORS' PRIORITY:

This authorization is consistent with the Board's priorities of a *Strong Agricultural Economy/Heritage and Efficient Delivery of Public Services* by following standard procedures for Williamson Act Contract cancellation requests.

STAFFING IMPACT:

Planning and Community Development Department staff is responsible for preparing all reports and attending meetings associated with the Williamson Act cancellation.


