Approved the proposed funding increases/decreases based on amended 1992-93 Notices of Grant Award (#2 and #3) for Older Americans Act (Title III) Aging programs funded through the California Department of Aging; authorized the Chairman to sign the amendments to contract #30-9293 with the California Department of Aging; and directed the Auditor/Controller to make the appropriate budget adjustments - Aging and Veterans Services S-37-J-18 93-461
