The petition will request the Court to grant a rehearing on the issue of whether or not the EIR complied with CEQA; requested the 5th District Court, if they do not grant a rehearing on CEQA to clarify the scope of the decision and instruct the trial court on remand to issue a writ to: 1.) Prepare a supplemental EIR to address the long term water supply; 2.) No order should issue suspending any ongoing activities not dependent on the long term water supply; 3.) Authorize the entire opinion to be certified for publication including sections II and III where the Court rejected the claims that the County failed to comply with the Williamson Act and CEQA, except for the long term water covered in Section I. The publication of Section II and III of this decision will assist other public agencies in the future.
