Changed service designation for five management classifications from the Classified Service to the Unclassified Service of the County in the following Departments: Purchasing; Library; Building Inspecting; Department of Environmental Resources; and, Health Services Agency and amended the Salary and Position Allocation Resolution to reflect the changes 97-995

Authorized the Chairman and CEO to sign the Annual Equal Rights Commitment Statement 97-996

Approved the Health Services Agency Ambulatory Patient Care Policy and Procedure Manual – HAS 97-997

Approved the description of proposed expenditure of California for Indigents Program Funds for Fiscal Year 1997-98 and authorized the HSA Director, or her Designee, to sign the description of proposed expenditure of California Healthcare for Indigents Program Funds – HAS 97-998

Authorized the Mental Health Director, or his Designee, to sign an agreement with the State Department of Corrections for the Residential Substance Abuse Treatment Services effective 1/1/98 through 12/31/00 - Mental Health 97-999

Authorized the Mental Health Director to continue the remodeling project at the Stanislaus Behavioral Health Center at 1501 Claus Road, Modesto; authorized the Auditor-Controller to make the necessary line item increases; and, authorized the Purchasing Department to award bids for the remodeling project - Mental Health 97-1000

Approved candidates for credentialing by the Managed Care Services Division of the Department of Mental Health as Behavioral Health Panel Providers for National Health Plans and authorized the Chairman to sign the Provider Recredentialing form - Mental Health 97-1001

Approved the Chief Probation Officer entering into a contract with Turlock High School District, Ceres Unified School District, Stanislaus Office of Education and Modesto City Schools in the amount of \$52,500 to provide consultation services to the Targeted Truancy and Public Safety Program; amended the Salary and Position Allocation Resolution to add one Deputy Probation Officer position through the term of the three year grant to accommodate the demands of the grant; and, directed the Auditor-Controller to increase Appropriations and Revenues by \$52,500 97-1002

Approved the modified agreement between the Department of Social Services and Yosemite Community College District to establish the Culinary Academy to provide intensive, work-based training in food service and hospitality and authorized the Director of DSS, or his Deputy Director Designee, to sign the agreement not to exceed the total contract amount of \$68,838 97-1003

Approved the Department of Social Services to accept additional Family Preservation and Support Program (FPSP) Funds Allocated by the California Department of Social Services; authorized the Director of DSS to issue a RFP for provision of Family Preservation and Support Program Services; and, authorized and directed the Auditor-Controller to make the necessary appropriations and estimated revenue adjustments 97-1004

Authorized the Auditor-Controller to make the monetary transfers; approved revisions #1 of Contract Change Order No. 1 amending the Final Contract Cost (\$118,814.82) for West Main Avenue at the Turlock Irrigation District Lower Lateral No. 4 Project, STPL-5938(018) 97-1005

Approved right-of-way acquisition agreement for the Hatch and Wilson Parcel for Crows Landing Road Widening Project; authorized Chairman to sign right-of-way acquisition agreement; and, authorized the Auditor Controller to issue a warrant in the amount of \$29,586 payable to Fidelity National Title Company for escrow #902357-TO 97-1006

Approved an updated version of the Disadvantage Business Enterprise (DBE) Program for the United States Department (USDOT) Funded Projects for the period from 10/1/97 to 9/30/98 97-1007

Approved increasing Revenues and Appropriations in the Morgan Shop Budget by \$230,000; approved the purchase of ten pickups using the Morgan Shop Budget; transferred the \$100,000 appropriation for the pickup purchase in the Road and Bridge Budget to the Interfund Appropriation; and, directed the Auditor-Controller to make the required financial transactions 97-1008

Approved Salida Park Account Expenditure to Grover Landscape Services, Inc., and authorized the Auditor-Controller to issue a warrant in the amount of \$2,717.53 payable to Grover Landscape Services, Inc. 97-1009

B/P unan. Approved the FY 1997/98 StanWORKs Plan for submission to the State Department of Social Services as required by AB 1542 and authorized and directed the Auditor-Controller to make the necessary appropriations and estimated revenue adjustments - DSS 97-1010 (1-302)

S/B 4-1 (Paul) Awarded a contract to Ross Carroll, Inc., of Modesto in the amount of \$1,483,394.40 for the widening of Crows Landing Road between Whitmore Avenue and 1,000 feet south of Service Road; authorized the Auditor-Controller to increase appropriations in the Project Account for the Crows Landing Road Widening Project by \$1,530,000; the Board finds the low bidder, Donald O'Berg was non-responsive in that: 1.) the bid was submitted after the time specified in the bid documents, the time was stamped at 2:05 p.m., the bid documents stated the bid must be filed "prior" to 2:05 p.m.. The Board notes that when O'Berg brought the bid in the other bidders were already in the Board Chambers opening bids. 2.) The low bidder, Donald O'Berg also failed to list a subcontractor for the thermoplastic stripping work which is a specialty item. O'Berg, some five days after the bid, later in a letter to Public Works, requested to have Chrisp Company, the subcontractor for the bidders listed their stripping subcontractor, to be added as a subcontractor. The Board finds that the intention of O'Berg was to use a subcontractor (Chrisp Company) and not do the work themselves and thereby were non-responsive to the bid documents 97-1011 (1-1788)

C/P unan. Approved GPA #97-04 and RA #95-05 for B&H Manufacturing Company; adopted and waived the reading of Ordinance C.S. 656; ordered the filing of a Negative Declaration based on the initial study; and find that the proposed General Plan designation of Industrial is consistent on an overall basis with the County General Plan 97-1012 & 97-1013 (2-2757)

P/B unan. Approved GPA #97-05 and RA #97-06 for Patricia Paul; order the filing of a Negative Declaration based on the Initial Study and other project amendments and information submitted by the applicant and commenting agencies; adopted and waived the reading of Ordinance C.S. 657; and, find that the proposed General Plan Amendment is consistent with the overall goals and policies of the Land Use Element of the County General Plan and the overall General Plan 97-1014 & 97-1015 (2-2168)

Referred to the Chief Probation Officer a letter from the California State Board of Corrections' request for Juvenile Detention Facility Construction under the Federal Violent Offender Incarceration Grant Program

Acknowledged receipt of claims and referred to the CEO-Risk Management the following claims: Edward C. Backman, Dale E. Backman, Harriet M. Backman; Raymond Simpson; and, Christina Hansen

Supervisor Caruso reported on a trip he took to Oregon regarding Parks and Recreations. He reported that a meeting will be held on the Crows Landing Air Strip Thursday at 10:00 a.m with Gary Condit's office to resolve outstanding issues.
