- Approved sponsoring and authorized the Department of Aging and Veteran's Services (Area Agency on Aging) to coordinate Senior Awareness Activities at the Stanislaus County Fairgrounds on 5/1/99; approved a resolution declaring May as Senior Awareness Month; authorized the Chairman to sign a letter supporting Senior Awareness Activities for volunteers to show when soliciting prizes and donations for Senior Awareness Day; and, requested each Boardmember to be available on Senior Awareness Day, Saturday, 5/1/99, to present the Senior Award (resolution) to the recipient from their district 1999-83
- Approved the FY 1998/99 Pest Exclusion Program agreement with the California Department of Food and Agriculture and authorized the Ag Commissioner to sign; directed the Auditor-Controller to increase appropriations and revenue; and, approved funding of previously unfunded position Agricultural Commissioner 1999-84
- Authorized the Emergency Dispatch Department to proceed with an upgrade of the computer aided Dispatch System for Y2K compliance and approved the necessary funding transfers and, directed the Auditor-Controller to increase Emergency Dispatch appropriations to fund the CAD upgrade 1999-85
- Approved the agreement with Yosemite Community College District for educational, vocational, and related services for StanWORKS participants and authorized the CSA Director, or his Assistant Director Designee, to sign the agreement not to exceed the total contract amount of \$255,000 Community Services Agency 1999-86
- Approved the State Department of Health Services Contract #98-15764 Immunization Project
  Subvention Program and authorized the HSA Managing Director, or her Designee, to sign and execute the contract Health Services Agency
  1999-87
- Approved contract #98-14629 with the State Department of Health Services for the Women, Infants and Children (WIC) Supplemental Nutrition Program and authorized the HSA Managing Director, or her Designee, to sign and execute the contract Health Services Agency 1999-88
- Approved closure of Modesto Library on Sunday, 2/14/99, in order to allow for installation of new lighting fixtures 1999-89
- Approved annexation of territory to the Sunset Oaks Lighting District without an election (River Glen Annexation); find that the territory of the Sunset Oaks Lighting District is owned by the

petitioner, and that petitioner's ownership represents 100% of the total assessed valuation of all taxable property within the territory proposed to be annexed into the said district; find that Stanislaus County C.S. 21.40.040 requires the installation of a street lighting system to serve territory; find that the territory proposed to be annexed is not within the limits of any other lighting district; find that public necessity and welfare require that the territory be annexed to the lighting district; ordered that the requirements of notice, hearing and election shall not be applicable to this proceeding pursuant to Streets and Highways Code Section 19056; ordered that the territory shall be annexed to the Lighting District of Stanislaus County; find the fact of filing of the petition was received by the Clerk of the Board on 2/2/99; ordered that pursuant to the Streets and Highway Code Section 19000, et seq., the cost of conducting and maintaining the lighting district shall be assessed against the individual parcels of land within the District's boundaries; directed the Clerk of the Board to send a certified copy of the resolution ordering the annexation to the Lighting District to the Department of Public Works, the offices of the Assessor, Elections, Auditor-Controller and the Clerk-Recorder; and, directed the Department of Public Works to send a certified copy of the resolution ordering the annexation to the Lighting District and all other required documents and the processing fee to the State Board of Equalization

Authorized the Auditor-Controller to transfer \$70,000 from Non-Motorized Vehicle Fund account to the project account for right-of-way acquisition and initial engineering expenses for a project to realign a portion of Orange Blossom Road East of Morrison Road

Approved request by Doug Fluetsch, representing the Greater Merced Chamber of Commerce, to hold a bicycle race on County roads on 2/28/99 and authorized the Director of Public Works to issue a permit for the event subject to standard conditions 1999-92

Approved the rescheduling of the Redevelopment Agency hearing from 2/23/99 to 3/9/99 at 9:15 am 1999-93

B/M (4-0)(Simon absent) Authorized the Mental Health Director, or his Designee, to negotiate preliminary agreements with Community Transitional Resources and Turning Point for the provision of services through an integrated services agency and directed the Mental Health Director, or his Designee, to return to the Board for approval of the most favorable contract - Mental Health 1999-94 (1-84)

Referred to the Sheriff's Department, District Attorney and Probation Department a copy of a resolution from the Los Angeles County Board of Supervisors regarding a request to the Governor to work with counties in seeking an equitable solution on the best utilization of funds for local law enforcement

Referred to the Community Services Agency a letter from the California Department of Social Services Emergency Food Assistance Program regarding State Augmentation to Support Hunger Relief Efforts
