Supervisor Caruso commented on the excellent care his mother received at DMC recently and Chairman Simon also said his family members had also received excellent care over this past week at DMC

The CEO noted that SB 204, which deals with the red imported fire ant, will be heard today and he will be sending a letter on behalf of the Board supporting Senator Lewis' bill that would provide General Funds to the State Department of Ag to assist in the eradication of the ant. At a recent CAO conference information was given regarding the education revenue augmentation fund and the reform legislation will most likely take two years to deal with. He also noted that there is a lot of interest in local government financial reform and that the County needs to track this issue closely. He said a number of bills are being proposed on the spending of the Tobacco law suit settlement money. The Governor's proposals on Trial Court Funding will be "dead on arrival" in the Legislature and that the State will meet its Trial Court obligations according to Senator Peace. He thinks labor relations will be an issue during the next two years and he may bring back to the Board some request regarding this issue. He also was able to speak with the CAOs of Santa Clara County and San Joaquin County regarding the toll road down Del Puerto Canyon Road into Santa Clara County and they were committed to seriously looking into the matter.
