Approved staff's four recommendations based upon staff report, the comments by staff, the statement of persons who have testified and makes the following findings: the rating panel of five members was formed and four of the individuals had special expertise or representative of client of family and perspectives and the rating panel selected Turning Point to be the superior responder to the RFP; that the Board notes and finds that Turning Point has provided services to adults with mental illnesses in Central California for twenty years and they have provided through a contract with Stanislaus County a specialized residential program for facility in Modesto; notes that Turning Point did receive the Challenge Award for services similar to the stated in the RFP; in addition the Board finds that the recommendations at a meeting on March 18th after conducting several hearings the Mental Health Board voted unanimously to recommend to the Board that Turning Point be awarded the contract and several member of the Mental Board have stated their opinions and statement that are include in the hearing and are incorporated in the record in the Board's decision in this matter; the Board has taken into consideration the financial track record of Turning Point in both this district and other districts and lastly the Board determines that Turning Point best met the criteria for necessary services set forth in the RFP; authorized the staff to negotiate a five year agreement with Turning Point, Inc., for the provision of services to individuals

with a serious mental illness through an integrated service agency beginning 7/1/99 through 6/30/04 and to be included in the Department's proposed budget for FY 1999-2000; authorized the Mental Health Director to sign an agreement with Turning Point, Inc.; directed staff, as part of the negotiations, to include the following in the agreement: a) To the degree possible and within the context of the proposal, that current service staff and member staff of the current provider have first opportunity for continued employment; b) that an appropriate number of Stanislaus County residents be added to the Corporate
