Approved the request by Modesto Disposal Service/USA Waste of California Inc., to modify the boundary description for Franchise Collection Area 3, merging Area 4 into Area 3 by taking the following recommended actions: A. adopted findings that the proposed boundary modification merging Areas 3 and 4 is in the public interest and necessary for the efficient administration of refuse collection and disposal in the County; B. adopted a resolution to modify the boundary description of Franchise Collection Area 3 to merge Area 4 into 3, as set forth in the boundary description and map, effective 90 days after written notice of such boundary modification is provided to the affected franchise holders, pursuant to Ordinance Section 9.08.120, subject to all of the following: 1.) that R&R Disposal, Inc., voluntarily terminates the Stanislaus County Refuse Removal Franchise Agreement (Area 4), including any rights or interests thereto; 2.) that Modesto Disposal Services/U.S.A. Waste of California, Inc., agrees to defend, indemnify and hold harmless the County and its officers and employees from any claim, action or proceeding against the County to set aside or modify the Board's decision to modify the boundaries of Franchise Collections Area 3 and Area 4; that Modesto Disposal Services/U.S.A. Waste of California, Inc., agrees to rate modifications that incorporate the lower of the Area 3 or Area 4 rates for each level and type of refuse collection service as set by the Board, and in effect as of the effective date of the boundary modification; and, that Modesto Disposal Services/U.S.A. Waste of California, Inc., acknowledges that the County, in the future, may competitively bid all or any portion of Area 3, including the merged Area 4; C. directed staff to give to the effected franchise holders 90-days written notice of such boundary modification; D. adopted a resolution renumbering Franchise Collection Area 5 (Turlock Scavenger) to Franchise Area 4; and, E. adopted findings that the proposed boundary modification is exempt from the California Environmental Quality Act on the ground that there is no possibility that the activity in question may have a significant effect on the environment, and directed the Department to file a Notice of Exemption with the County Clerk - Environmental Resources 1999-340 (2-845)
