- Approved the 1999/2000 Annual Goal for Disadvantaged Business Enterprise to Participate in 11% of Projects that are funded in part or in whole by the U.S. Department of Transportation, the goal will be in effect from 10/1/99 to 9/30/00 and authorized the Clerk of the Board to publish a notice requesting comments on the goals in a paper of general circulation in Stanislaus County 1999-720
- Approved contract CO #1 for the Local Roads Rehabilitation Program - STIP contracted with George Reed, Inc.; authorized the Auditor-Controller to make the financial transactions; authorized the Purchasing Department to increase the contract amount by \$147,756.45 for a contract total of \$2,124,257.59 1999-721
- B/C unan. Authorized the approval of a MOU between the City of Modesto and Stanislaus County allowing use of Modesto City-County Airport Property for Parks purposes and authorized the CEO to execute the MOU on behalf of the County - Parks and Recreation 1999-722 (1-1050)
- C/M unan. Amended the Salary and Position Allocation Resolution to upgrade one Sergeant to one Lieutenant (Management Band D) in the Sheriff Operations Legal Budget Unit; authorized the CEO to sign the amended Stanislaus Drug Enforcement Agency (SDEA) Joint Powers Agreement; authorized the Auditor-Controller to establish the necessary accounts to transfer the

financial responsibility for the SDEA, JPA and related grant funding to the County from the City of Modesto; and, increased the Appropriations and Estimated Revenues - Sheriff 1999-723 (1-1552)

Referred to the CEO a copy of the Final Report for Fiscal Year 1998/99 from the Mountain-Valley Emergency Medical Services Agency summarizing some of the significant issues addressed by the Agency during this Fiscal Year

M/C unan. Approved the Assembly Republican Caucus recommendation to oppose Assembly Bill 84 prohibiting local government from approving big retail discount stores in their communities 1999-724

Acknowledge receipt of claims and referred to the CEO-Risk Management the following claims: Lana Jean Ward; Ken Nichols; and, Jacob Smith

Supervisor Paul noted that she attended the Waterford City Council meeting which endorsed the County's Visioning Plan. She noted that the Oakdale City Council has not supported the plan so far.

Supervisor Blom noted that the San Joaquin Valley Air Pollution Control District held a symposium in Modesto.

Supervisor Mayfield will be attending a meeting in Sacramento regarding the Turlock Lake Park.

The CEO informed the Board that a bill is on the Governor's desk regarding our loss of Tobacco Tax Bill funding.
