Supervisor Blom said the Heart Walk last Saturday, that Sheriff Weidman and he co-chaired, was a success and he wanted to express their greatest thanks to Lt. Erwin for all the work she did. Supervisor Mayfield reported on his trip to Sacramento with Gordon Dewers and the State Director of Parks regarding the Turlock Lake concession. He said that another meeting would be held in late October to further explore a partnership with the State, County and TID.

The CEO noted that the State is about to conclude their legislative session and the Governor is signing or vetoing bills. In thirty days he will bring back a report on the outcome of these bills.
