Supervisor Caruso is concerned about a recent article he read on the City of Turlock's General

Plan Update and the upcoming FOOD Initiative. The CEO noted that there is an upcoming Visioning meeting where this issue could be discussed. Chairman Simon suggested that the Board may want to speak out against the FOOD Initiative. The CEO also said that the initiative will go to the citizens of each city and to the County residence as separate initiatives and if passed in one jurisdiction and not others it would create additional planning issues.

Supervisor Paul suggested that the local youth may be contacted to paint murals at SMC in order to put a new, clean look on the facility.

The CEO recommended to the Board that the 1/4/99 Board meeting be canceled

Chairman Simon and Supervisor Blom noted a recent Modesto Bee article said that they were not not going to run for re-election again. Both said that they had yet decided whether they were going to running or not.
