B/M unan. Approved a resolution allowed for by AB1482, that delays the implementation of Chapter 752 and directed Animal Services staff to develop a plan enabling the County to meet the holding requirement of Chapter 752 as soon as practical, but no later than 6/30/00 - Animal Services 1999-1008

P/M unan. Approved a resolution to transfer a portion of Stanislaus County Unappropriated Monies for Underground Electric Lines (Rule 20A) in the amount of \$495,00 to the City of Riverbank 1999-1009

P/B unan. Approved the Tentative Map Application No. 99-04 -River Ranch; directed the Public Facility Fee Committee (Planning, Public Works, Development Services, Auditor-Controller, County Counsel) and the Parks Department and DER to undertake the development of a "Parks and Open Space" acquisition fee to be applied on a County-Wide basis; and, referred the matter of east Oakdale planning to the General Plan Update Committee for considerations and recommendations to the Board 1999-1010

B/P unan. Based on the Initial Study, the mitigation monitoring plan and the environmental documents contained in the administrative record, find that you have considered the environmental documentation and filed a Mitigated Negative Declaration; find that the proposed General Plan Amendment No. 99-04 is consistent with the overall goals and policies of the Stanislaus County General Plan and with the overall plan as well; find the project to be "de minimis" for the purposes of Fish and Game codes; approved General Plan Amendment #99-04 for MTC Distribution; find that the proposed PI zoning is consistent with the Planned Industrial General Plan Designation; find that the project will intensify use of the site, thereby necessitating dedications and improvements; and, approved Rezone Application #99-07 and introduced, adopted and waived the reading of Ordinance C.S. 715 for M.T.C. Distributing subject to the Mitigation Monitoring Plan and Development Standards; and, based upon staff report, comments by staff including the modified development standards set forth by staff and accepted by the applicant ORD-54-D-15 1999-1011 & 1999-1012

B/C unan. Based on the Initial study, the modified Mitigation Monitoring Plan, and the reduction of the project from 50 to 16.55 acres in area, order the filing of a Mitigated Negative Declaration; find that the proposed General Plan Amendment #99-07 is consistent with the overall goals and policies of the Stanislaus County General Plan, and with the overall plan as well; find that the project to be "de

minimis" for the purposes of Fish and Game codes; approved General Plan Amendment #99-07 for the 16.55 acre portion of APN:12-13-37; find that the proposed PI zoning is consistent with the Planned Industrial General Plan designation; find that the project will intensify use of the site, thereby necessitating dedications and improvements; find that due to the proponent modifying the project from 50 acres down to 16.55 acres mitigates impacts in the areas of air quality, agricultural land and noise and are equivalent to, or more effective than, mitigation measures #2 and 5 in mitigation or avoiding potential significant effects, elimination will not cause any potentially significant effects on the environment, no recirculation of the proposed mitigated Negative Declaration pursuant to CEQA guidelines Section 15072 and 15074.1 is required; and, approved Rezone Application #99-13 and introduced, adopted and waived the reading of Ordinance C.S 716 for Flory Industries subject to the modified Mitigation Monitoring Plan and Development Standards; and, waived the 35 foot height limitation to allow construction of a 45 foot high building ORD-54-D-16 1999-1013 & 1999-1014

C/M unan. Approved the General Plan Amendment # 99-06 for Jimmy Sanity to change the General Plan designation on a 0.26 acre site from Industrial Transition to Industrial and to rezone from Medium Density Residential (R-2) to Industrial (M) for the purpose of operating an ice cream storage and wholesale facility from existing structures at 231 Santa Cruz, Modesto; and, approved Rezone Application #99-12 and introduced, adopted and waived the reading of Ordinance C.S. 717 for Rezone Application #99-12; ordered the filing of a Negative Declaration; and, find the project be "de minimis" for the purposes of Fish and Game codes ORD-54-D-17 1999-1015 & 1999-1016

The public hearing to consider the Planning Commission's decision to continue General Plan Amendment Application No. 99-01, Rezone Application No. 99-01, and Tentative Subdivision Map Application Nos. 99-01, 99-07, 99-08, and 99-09 - Pimentel, Runyan, Naranjo and Peacock Development was canceled per request by the applicant that was received by the Clerk of the Board on 12/9/99

Referred to the Department of Planning and Community Development a letter from the United States Department of Housing and Urban Development regarding Community Development Block Grant applications

Referred to the Department of Employment and Training a letter from the State of California Health and Human Services Agency regarding the submission of the strategic five-year local plan for Title I of the Workforce Investment Act

Accepted the 1999-2000 Emergency Dispatch Annual Report

Acknowledged receipt of claims and referred to the CEO-Risk Management the following claims: Rose Murphy; Richard Calvin Casey; Karen Green; Corine De Airozo; and, Gerald McCulloch

Supervisor Blom requested that the Board extend the Clerk-Recorder's office hours to be open from 8 a.m. to 5 p.m. Discussion ensued regarding the closing of the Clerk-Recorder's office on 12/31/99 for the New Year's holiday. Supervisor Caruso requested that the Clerk-Recorder's office remain open on 12/31/99.

B/C unan. Approved item Too Late for the Agenda based on a determination that there was an immediate need to take action that arose after the agenda was posted and that the Board was under the

belief that the Clerk-Recorder had been contacted and was, as in previous years, going to stay open for a portion of 12/31/99 to allow for documents to be recorded prior to the end of the year; the Board was informed, that night, that the Clerk-Recorder had declined a request by the CEO's Office to stay open and had denied the request; therefore, the Board needed to and did take action on this item at tonight's meeting to see that the Recorder's Office would remain open as the Board does not meet again until 1/11/2000; the Board took two votes, both unanimous, with the first vote taken for the need to take immediate action in order to see that the Clerk-Recorder's Office would be open on 12/31/99 and that the need to take action came to the attention of the Board at the meeting and after the agenda had been posted and, with the second vote taken to have the Clerk Recorder's Office open for business on 12/31/99, from 8:00 a.m. to 12:00 p.m.

C/B unan. Directed the Clerk-Recorder, pursuant to Section 2.56.010, that on 12/31/99 the Clerk-Recorder shall be open for business during the hours of 8 a.m. to 12 noon and authorized the CEO-Personnel Director to make the appropriate adjustments in staff schedules and salaries 1999-1018

Supervisor Paul noted that on the CSAC Bulletin there is a \$25,000 grant from the State Integrated Waste Management Board to be used to shred tires for playgrounds
