Supervisor Blom asked if the Clerk-Recorder had responded to the Board's request, the CEO said that a letter had been sent and no response had yet been received.

Supervisor Simon commented on a letter sent by Supervisor Paul and Councilmember Frohman regarding the relationship between the County and the City. He took issue to comments made in the Modesto Bee regarding his relationship with the City. Councilmember Frohman explained that his comments to the Bee were not intended to attack Supervisor Simon nor did they accurately reflected his comments.

Supervisor Mayfield said he looked forward to meeting with the City but does not plan to discuss the reduction of the Waste-to-Energy plant rent

Supervisor Blom commented on the recent meeting of the San Joaquin Valley Unified Air Pollution Control District and also commented on State legislation regarding stationary sources.

Chairman Caruso noted he was recently voted President of the Emergency Dispatch JPA

The CEO noted that the State is working on their budget and their expected surplus of funds. He requested the Board to check their calendar for 3/28/00 for a possible date for the next Board Retreat
