Supervisor Pat Paul, Chair of the Stanislaus County Board of Supervisors, gave the State of the County Address for 2001.

Presented to CSA a Proclamation for Eligibility Worker Recognition in Stanislaus County during the week of 1/22/01.

A Certificate of Achievement from the Government Finance Officers' Association for Excellence in Financial Reporting was presented to the Auditor-Controller's Department.

Grace Cox thanked Chair Paul for making the issue of health a top priority in Stanislaus County, and thanked Supervisor Caruso for his work as Chairman in the year 2000.

John Mataka spoke regarding safety concerns at the intersection of Grayson Road with Cox and Laird Roads, in the Westley area, and submitted to the Board a petition requesting that a four-way stop be placed at this intersection. He acknowledged that Supervisor Caruso, the Grayson Community Services District and County staff addressed this issue seven months ago. He also requested that the Board and Sheriff Department be involved in the demographic data collection concerning racial profiling.

Raul Ortega expressed his pleasure regarding the increase in new jobs within Stanislaus County due to building projects. He said that the community would like to see collaboration between the City and the County for building projects in target areas.

Supervisor Caruso asked if a 24 hour County telephone number had been established. The number will be given out at the next Board meeting. He also updated the Board on progress of the Crows Landing Naval Air Base.

Chair Paul requested that StanCOG become part of the joint project with San Joaquin County regarding the study of the Patterson Road, Ladd Road and McHenry Avenue intersections.

Adjourned to Closed Session at 12:00 p.m. for conference with legal counsel on anticipated litigation/significant exposure to litigation on two potential cases, pursuant to GC §54954.5(c); and, for Personnel-Public Employment: Performance Evaluation – CEO, pursuant to GC §54954.5(e).
