John Mataka spoke on behalf of the Grayson Neighborhood Council regarding their opposition to the California Waste Management Board's funding to restart the Modesto Energy, LP (MELP) Tire Burning Plant in Westley. He expressed concerns regarding the thoroughness of the cleanup of the tire fire site, as well as ground water contamination of nearby farm wells and all other ground water tables surrounding the tire fire site. He requested that the Board oppose the re-opening of the Tire Burning Plant.
