- ***D1** Approved rescinding Williamson Act Contracts 76-2054 and 78-3141 and approve new contracts - pursuant to Minor Lot Line Adjustment 96-46, and authorized the Planning Director to execute a new contract; finds that the new contract or contracts would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years; finds that there is no net decrease in the amount of the acreage restricted - in cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; finds that at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts; finds that after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Govt. Code §51222; finds that the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract or contracts; finds that the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; and, finds that the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the General Plan – Planning and Community Development 2001-862

B/C unan. ***B2** Approval of Labor Agreement between the County and the Stanislaus County Employees Association, AFSCME Local 10 representing four bargaining units; implemented the provisions contained with the Tentative Agreement reached between the County and the Stanislaus County Employees Association, AFSCME Local 10 representing the Mid-Management/Supervisory, Office Worker/Clerical, Crafts Maintenance/Institutional, and Technical Services Bargaining Units; amended the Salary and Position Allocation Resolution to reflect the changes agreed to; applied the new adjusted salary ranges to extra help employees in the affected classifications; and, granted the two unrepresented classifications of Clerical/Community Aide I/II the four across-the-board adjustments that are effective in June of each year with the first adjustment of 3.75% to occur after the start of the first pay period on 6/1/01; and, amended the item to add that if a signed petition by at least 30% of the eligible voters for each individual bargaining unit is returned to the Board, that a proctor other than the Chief Executive Office be appointed to oversee a new election – CEO 2001-865

B/S unan. ***B3** Approved compensation changes for management and confidential employees that are consistent with the negotiated compensation changes with six of the ten bargaining units that represent over ninety percent of the workforce; approved compensation changes for unrepresented extra help employees; amended the Salary and Position Allocation Resolution to reflect the changes; and, approved an amendment to the item to add an enhanced retirement benefit that is consistent with retirement benefits negotiated with the bargaining units, to include a two percent (2%) at 55 formula for general members and a three percent (3%) at 50 formula for safety members, with a target implementation of 3/1/02- CEO 2001-866
