M/B unan. **B6** Amended the item to correct Staff Recommendation #1 as follows: Approved consolidation request of the City of Modesto to conduct the previously scheduled 12/11/01 City Council Runoff Election with the 3/5/02 local, State and Federal Primary Election; directed the CEO to request the Secretary of State to assist and oversee the conduct of the 3/5/02 Primary; requested the Secretary of State to conduct an immediate independent investigation of the failed election; directed the CEO to conduct an investigation and report back to the Board with findings and recommendations no later than the first Board Meeting in CY 2002, scheduled for 1/8/02; directed the County Counsel to pursue, as appropriate, any legal redress against any of the vendors whose delay or failure to perform resulted in the failed election; in addition to the oversight and investigation requested of the Secretary of State, the Board approved the establishment of a committee of citizen volunteers of up to 15 persons including representation from the City of Modesto to do the following: a.) review the report and recommendations of the CEO being provided to the Board on 12/11/01 and the follow-up report to be provided on 1/8/02, and provide the Board with any further new recommendations they deem appropriate; b.) oversee the preparations for the 3/5/02 Primary Election and to observe its conduct on Election Day; and, c.) work with the Interim Clerk-Recorder in these processes; ordered that a committee be formed by requesting volunteers to apply with the Clerk of the Board up through 1/2/02 with the intention of making the appointments on 1/8/02, as part of the report; authorized the transfer of \$18,000 from the Special Projects Budget to the Elections Budget in order to purchase two additional printers; amended the item to change the date in the last sentence of paragraph #1 in the discussion section from 11/26/01 to 11/23/01 and to change the date in the first sentence in paragraph #9 of the discussion section from Wednesday, 11/28/01 to Thursday, 11/29/01 and to include the following Board requests: 1.) operations, 5.) the Board address the structural needs of the citizen committee, 6.) that the Board provide immediate funding for more equipment changes, 7.) the County and Clerk's Office conduct a thorough review of all the vendors and all their contracts relating to the mail services, printing of ballots, and the envelope service, 8.) the Clerk's Office conduct a thorough review of all the security measures that take place in the Clerk-Recorder's Office and maintain a log of who has access to the Clerk and the Clerk's area, as well as the counting and movement of the ballots, and 9.) the Clerk's Office conduct a review of the mechanisms employed that would provide fail safe accountability of the incoming and outgoing ballots – CEO C-6-H-15 2001-968

C/B unan. 9:50 a.m. Finds that the environmental review for Diablo Grande is adequate and complete and supports modifying Conditions #51 and #57 - this finding is based on all available and previous CEQA documentation and findings prepared and/or certified by Stanislaus County, Kern County Water Agency and its subcontractors, and Western Hills Water District, in regards to the Diablo Grande project, and this finding takes into consideration actions taken by these agencies and the judgement and writ issued by the Stanislaus County Superior Court in 1999, and is also based on the information presented in this report and the attachments to this report, including the attached Addendum to the Final EIR pursuant to CEQA Guidelines §15164; modified Condition of Approval #57 for Vesting Tentative Map #97-01 as follows: prior to recording any final map for Phase 1 development that has anticipated water needs beyond that supplied by on-site wells, Diablo Grande and/or Western Hills Water District shall obtain all required governmental approvals necessary for supplying all anticipated water needs of Phase 1 from the Berrenda Mesa or Kern County Water Agency (KCWA) supply options; modified Condition of Approval #51 for Vesting Tentative Map #97-01 as follows: prior to final inspection of any dwelling, Diablo Grande shall provide an approved, all-weather road for emergency vehicle access or adequate on-site public safety facilities. If an emergency access road is constructed, this road shall be built and maintained to provide year-round access by a two-wheel drive Sheriff's cruiser and by a standard firefighting water-tender; ordered that the department of public works will assist in making certain that the emergency access road, if constructed, is designed and constructed to adequate standards; and, the Board denied the appeal by Mr. Steve Burke and adopted the Planning Commission's recommendations 2001-979
