B10 Approved in concept a plan, and authorized staff to determine the feasibility to combine the development of designing and constructing an office building and the parking garage at 12<sup>th</sup> and I Streets in Modesto; approved in concept an approach for a public/private partnership project, which would include the development of air space subdivision rights for retail use on the ground floor of the office building by a private party and the private use of 40 parking spaces, subject to the approval of the City of Modesto and the Modesto Redevelopment Agency; authorized staff to negotiate an agreement with the City of Modesto for the purchase of real property at 12<sup>th</sup> and I Streets in Modesto, contingent upon the Final Phase II Hazardous Assessment Plan for the property; authorized staff to negotiate an agreement with Westland Development relating to the reimbursement of Westland's costs, the sale of the proposed first floor private retail/office space, the development of air space, and the licensing of parking spaces; and, authorized CEO staff to return to the Board with specific recommendations, plan of action, a budget, and a schedule 2002-87
