***A4** Modified the Board of Supervisors' Meeting Calendar to set two joint City-County meetings on 3/19/02 at 7:00 p.m. in Turlock and on 10/15/02 in Hughson at 7:00 p.m. 2002-90

***A5** Approved request from the Haven Women's Center of Stanislaus County for use of the Courthouse lawn on Thursday, 4/4/02, for the Walk for Awareness event honoring Sexual Assault Awareness Month 2002-91

***B1** Authorized the CEO, or his Designee, to lease additional office space located at 147 South Broadway, Turlock, CA 95380, for the DAFS Division; directed the Auditor-Controller to increase appropriations; and, authorized the purchase of fixed assets 2002-92

***B2** Approved the agreement between Community Housing and Shelter Services and BHRS to provide Sober Living Housing; and, authorized the Director of BHRS, or his Designee, to sign the agreement to be effective 2/16/02 2002-93

***B3** Accepted the Stanislaus County Juvenile Justice Facility Electronic Security Upgrade Project; approved the final contract with the contractor, Central California Electronics, for a total contract cost in the amount of \$106,894; authorized the Chairman on behalf of the Board, as the awarding authority, to sign the completion documents; accepted the project and authorized the necessary recording of the final NOC and all other necessary close out activities; authorized the submittal of grant contracts for Juvenile Hall Security Electronics and Fire System Upgrades for funding from the Board of Corrections; and, approved the associated grant resolution 2002-94

***B5** Introduced and waived the first reading of Ordinance C.S. 787 amending §9.70.050 of the County Code to change the membership on Stanislaus County's Children and Families Commission to read: The Commission shall consist of nine (9) members. The membership shall consist of one (1) member of the Board of Supervisors; one (1) County Health Officer; two (2) of the following County Department Heads: Health Services Agency, Behavioral Health and Recovery Services, or the Community Services Agency; one (1) representative of a local school district; and four (4) members who represent any of the following categories: (a) recipients of project services included in the Strategic Plan, (b) educators specializing in early childhood development, (c) representatives of a local child care resource or referral agency or a local child care coordinating group, (d) representatives of a local organization for prevention or early intervention for families at risk, (e) representatives of community-based organizations that have the goal of promoting nurturing and early childhood development, (f)

representatives of local school districts, and (g) representatives of local medical pediatric or obstetric associations or societies – CEO ORD-54-J-5 2002-95

- *B6 Adopted a resolution regarding retirement benefits; implemented the provisions contained in the Enhanced Retirement Benefits Agreement; extended the benefit changes to eligible employees in accordance with provisions contained in the Enhanced Retirement Benefits Agreement; closed Tier III to all new hires on or after 3/9/02; and, directed the CEO to implement the provisions contained in the Enhanced Retirement Benefits Agreement with respect to Stanislaus County employee members of the SCERA 2002-96
- *C1 Approved the Plans and Specifications for the Intersection of Finch Road at Mariposa Road Traffic Signals Project; directed the Clerk of the Board to publish notice inviting bids for the project as required by law; set the deadline for submission of bids as 3/14/02, prior to 2:30 p.m.; directed the staff of Public Works to mail the notice inviting bids to Trade Journals as required by law; and, directed the Auditor-Controller to increase appropriations by \$3,000 in the project account to cover the costs of advertising and publishing 2002-97
- *C2 Approved the Plans and Specifications for the Westley Triangle Landscaping Project; directed the Clerk of the Board to publish notice inviting bids for the project as required by law; set the deadline for submission of bids as 3/14/02, prior to 3:00 p.m.; directed the staff of Public Works to mail the notice inviting bids to Trade Journals as required by law; and, directed the Auditor-Controller to increase appropriations by \$5,000 in the project account to cover the costs of advertising and publishing 2002-98
- *C3 Approved the LaGrange Road Bridge at Tuolumne River Bearing Pads Replacement Project as a Public Works Project; and, directed the Auditor-Controller to increase appropriations for preliminary design engineering in the amount of \$23,000 2002-99
- *C4 Approved the Mitchell Road Bridge at Tuolumne River - Approach Slabs Concrete Median Barrier Rail Replacement Project, as a Public Works Project; and, directed the Auditor-Controller to increase appropriations for preliminary design engineering in the amount of \$60,000 2002-100
- *C5 Approved the filing and recording of the final map of River Ranch Subdivision; finds that the final map is in substantial compliance with the previously approved tentative map; finds that Stanislaus County has adopted a Specific Plan covering the area proposed to be included within the final map; finds that the final map, together with the provisions for its design and improvement, is consistent with the Specific Plan for the area; rejected all roads, highways, avenues, alleys, courts, ways, lanes, places, etc.; authorized the Chairman to sign the final map and the Subdivision Improvement Agreement; and, authorized the final map to be filed and recorded as presented – PW 2002-101
- *D1 Approved Salida Planned Development Road Account expenditures to O'Dell Engineering; and, authorized the Auditor-Controller to issue a warrant in the amount of \$6,586.50 to O'Dell Engineering – Planning and Community Development 2002-102
