Robert Stout, City of Modesto Finance Director, presented a Certificate of Achievement for Financial Reporting to Larry Haugh, Stanislaus County Auditor-Controller.

Juanita Jackson thanked Supervisor Blom for his assistance in getting Spencer Avenue re-paved. She also noted that work needs to be done in the Monterey Park Tract Community Services District, and requested that the City and County work together to incorporate the existing County islands into the City of Modesto.

CEQA, the Board certified that it has considered the Mitigated Negative Declaration prepared by the
Salida Union School District; finds that the project will not result in a significant impact to the
environment; finds that there are no additional feasible alternatives or Mitigation Measures within the
power of the County that would substantially lesson or avoid any significant effect the project would have
on the environment; directed staff to file a notice of determination as required by statute; authorized the
CEO to execute the Joint Project Agreement with the Salida Union School District, which provides for the
purchase of 12 acres of property located at 5990 Pirrone Road, Salida, for a park, and the joint use of
property and recreational facilities; authorized the CEO to execute the escrow and other documents
necessary for the purchase of the property from the Salida Union School District; and, finds that the
Notice of Intent to Purchase the property was published by the Clerk as per GC Section 25350

Supervisor Simon noted that Senator Boxer attended an event to open a bike path through Modesto. He and Chairman Mayfield met with the Presiding Judge Mayhew and Judge VanderWall regarding the funding of the Grand Jury. He reported that at the TRRP meeting a presentation was made regarding property located at Melrose Avenue and the 7th Street Bridge where an individual is seeking to build a skating rink.

Supervisor Caruso attended a meeting in Bakersfield on local government. On 8/14/02, he will be attending a meeting in Fresno for the Multi-County Water Coalition. He noted the level of smog that is currently in the valley.

Supervisor Paul represented the Board at the dedication of the bike path with Senator Boxer and the Senator invited the County to bring their "wish list" to the next NACO Legislative Conference in February 2003. She attended the groundbreaking ceremony for a new gymnasium in Oakdale that is a collaboration project between the County, City schools, and the City of Oakdale.

The CEO reported on the status of the State Budget and the County's budget. He noted the State is 44 days behind in adopting their budget, which forces the County to complete its budget with contingencies to give the Board options to deal with issues that may arise during the upcoming FY.
