Chairman Mayfield presented to Mary Moore from the Library, a resolution proclaiming the month of October 2002 as "The Grapes of Wrath Month" to encourage reading and story sharing within Stanislaus County's diverse cultural communities.

Claudia Krausnick from the CEO/CARE Unit and David Ingersoll from CSS, presented an Employee Suggestion Award and check to CSS employee, Shelly Antonucci, and congratulated her upon her award.

A presentation was given by the Community Development Director of the City of Turlock, Charlie Woods, and Bruce Race from Race Studios, on the Turlock Broadway Street Mixed Use Workshop for the mixed use possibilities for downtown Turlock, and a possible Turlock Regional Library site opportunity.

Kathy Halsey from SBC Pacific Bell spoke regarding their high speed Internet service and the quality of service provided by Pac Bell's various networks, as well as the maintenance and training schedules implemented to ensure continuity and maintain excellent service levels.

Kimberlie Nevel, an IHSS care provider, requested the adoption of an Employee of Record for the IHSS providers.

Allan Dix, owner of Salida Auto Dismantlers, spoke regarding staffing issues at the Sheriff's Salida Substation and voiced concerns regarding the sewer project near his property line.

Supervisor Caruso attended a meeting with the California Transportation Commission in San Diego where he successfully secured the necessary funding in the amount of 21.1 million for the Kiernan Road Project. He thanked Kirk Lindsey, StanCOG, and staff for their support and hard work in helping the County to obtain this important funding. He also attended the Sheriff's Awards Dinner. He noted that he was indirectly involved in a traffic accident on Highway 120 and emphasized the need for improvements at certain intersections to prevent similar accidents from occurring.

The CEO reported on the upcoming Connecting Stanislaus Event to be held at the Modesto Centre Plaza this Friday, 10/11/02.

The Chairman announced that next Tuesday's Board Meeting will be a joint meeting between the Stanislaus County Board of Supervisors and the Hughson City Council. The meeting will be held at 7:00 p.m. on Tuesday, 10/15/02, at Hughson City Hall, 7018 Pine Street in Hughson, CA.

(Note: reconvened at the Agricultural Center, Harvest Hall, 3800 Cornucopia Way, Modesto, CA, for discussion of the report on the Draft Environmental Impact Report (EIR) on the Fink Road Landfill Expansion and direction to staff for modifications to the Draft EIR for a project sized only for the needs of Stanislaus County).

C/S (3-2) (Mayfield and Blom opposed) **C7** The Board of Supervisors directed staff to revise and recirculate the Draft Environmental Impact Report ("EIR") for expansion of the Fink Road Landfill for a project that meets the needs of the County by development of a landfill at the southern end of the County's expansion area approximately 129 acres in size, and to develop concepts for the possible use for the land around the landfill that is not needed for expansion, buffers, or environmental mitigation. The Board also directed staff that the EIR should not provide for importation of garbage from outside of Stanislaus County for disposal at the landfill, and should limit the County's current per day cap on garbage dumped at the site to the currently permitted amount of no more than 1,500 tons per day. In addition, the Board directed staff to look for, as well as obtain community input on, parks and recreation opportunities on the surrounding acreage that are considered good uses for the Westside, and directed staff to consider options to limit or prohibit importation of waste for disposal at the County landfill, such as adoption of a host fee – PW 2002-794
