Supervisor Grover noted that on 10/24/03, Congressman Radanovich and Congressman Cardoza may be visiting our County regarding the Tiger Salamander, and have asked the U.S. Fish and Wildlife Service to make a presentation of scientific findings.

Chairman Simon asked County Counsel how much time and information is required by law to address a constituent's questions. He raised concerns regarding the amount of County staff time being used to answer repeated questions from one citizen regarding the landfill. County Counsel noted that the Public Records Act allows a citizen to request documents from a public agency. County Counsel also noted that he has responded to all requests for documentation and information as well as meeting with certain constituents.
