Supervisor Caruso noted that he met with staff of the Riverdale Community Service District last night regarding the state of their community and the improvements they want to see made.

Supervisor Paul noted that she and Chief Probation Officer Jerry Powers were the MC for the Anti-Hate Rally program, and there was a very good turn-out of people who marched to Graceda Park.

The Interim CEO mentioned that there are a number of equal rights activities going on throughout the month of October. She noted that staff is developing a Race Communication Class at Probation, a new Crossing Cultural Bridges Class, and the Equal Rights Plan and activities this year. She also noted that the whole County organization is sensitive to this issue, and that staff is working with County departments to ensure that we have sensitivity about our diversity.

The Interim CEO reported on the State Budget. She noted that the Legislature is not in session, and is scheduled to reconvene on 1/5/04. This past weekend Governor Davis handled over 200 bills, one of which permits swimming in the Modesto Reservoir. Governor Davis is in the process of making over 100 appointments to State Boards and Commissions before he leaves office. The new Governor will take office on 11/15/03, and he has appointed a 68-member transition team. CSAC is encouraging a structural overhaul of the State and local government relationship with regards to financing property and sales tax.
