Supervisor Paul asked for a status update regarding the Keeney property on Yosemite Avenue. She asked if there is a limit to how many times the County cleans up a piece of property. She noted that the County has cleaned property on McCoy in Empire twice, costing \$10,000, and the property owner has recently brought in another truckload of items. County Counsel will look into this matter and follow-up with Supervisor Paul.

The Interim CEO noted that the State extended the deadline for the bond measure to 12/10/03. She gave an update regarding the DMV not distributing any Vehicle License Fees (VLF) to either counties or cities, or to the realign VLF that support our health care programs, until all the refunds are made to the citizens who paid the higher VLF. The County's General Fund is allocated \$2.7 million every month. If the refund process takes 2 months, the County will lose an additional \$5.4 million in the General Fund in the current year. The Health Fund Trust that funds HSA, BHRS, and others could loose an additional \$5 million. She will continue to keep the Board updated on the Budget proposal.

Leg A Verbal report was given by the Planning and Community Development Department regarding AB 1492 – Williamson Act changes.

Supervisor Mayfield met with the Executive Director of the San Joaquin Valley Air Pollution Control District regarding his position as the Vice-Chairman of the District in 2004.

The Chairman announced that the Special Board of Supervisors Closed Session noticed on the agenda for 12/16/03 at 3:00 p.m. will be rescheduled (Public Employee Appointment: Title: Chief Executive Officer. Government Code §54954.5(e)).

The Chairman announced that on 1/27/04 at 1:00-3:00 p.m., Basement Chambers, $1010 \ 10^{th}$ Street, Modesto, the Board of Supervisors will sponsor the Central California Chamber Alliance, which is a manufacture's summit that is being brought to each County. Boards of Supervisors throughout the State will be sponsoring this summit on the same day to develop a policy to take to the Governor regarding legislation that is driving business out of the State.

The Chairman announced that there will be a reception in honor of the Stanislaus County Fire Fighters who served in the 2003 Southern California Fires on 12/16/03 at 5:30 p.m. (prior to the Board of Supervisors Meeting) in the Basement Foyer, 1010 Tenth Street, Modesto, CA.
