Paul/Simon unan. **Closed Session Announcement:** The Board received a letter (Correspondence Item No. 1) dated 6/8/04 from Kevin Williams, the Director of the Department of Environmental Resources and the Department of Parks and Recreation, stating that he will retire from County service in June 2005, that he has accepted an assignment in the Office of Emergency Services working on homeland security and other projects, and that he will be leaving the position of Director of the Department of Environmental Resources and the Department of Parks and Recreation effective at the close of business on 6/22/04; the Board discussed in Closed Session the appointment of the Interim Director of the Department of Environmental Resources and the Department of Parks and Recreation; and, upon the recommendation of the Interim CEO, the Board appointed Sonya Harrigfeld as the Interim Director of the Department of Environmental Resources and the Department of Parks and Recreation effective 6/23/04 starting at Salary Band G at \$111,472 2004-471

The Sheriff updated the Board regarding the health of former Sheriff Dan Kelsey.

The Sheriff Department's Salida Substation received the 2004 James Q. Wilson Award for Excellence in Community Policing, sponsored by Regional Community Policing Institute of Los Angeles for the State of California.

Joanne Waters spoke regarding the Linkages Program and how it has been impacted by the County budget.

Walt Coolidge spoke regarding the homeless shelter on 9th Street in Modesto that was recently closed because the permit has run out, and is not scheduled to reopen until November. He noted that this shelter has 85 beds, and individuals have been displaced. The Board directed him to Janice Keating, Modesto City Councilmember, who is working on this issue.

Kristi Rosenquist, an UDW employee, spoke regarding the closure of the homeless shelter. She thanked the Sheriff's deputies that work in Salida for their help in contacting her daughter during a family

emergency. She gave the Board copies of letters from the community supporting a wage increase for IHSS employees. She reported that she is having problems with neighbors across the street from her home.

Gertie Thornhill, an IHSS worker, spoke in support of a wage increase and health benefits for IHSS employees.

Patricia Boyd noted that a Sheriff's Deputy stopped and helped her after she was in a car accident, and offered to be a witness if needed. She spoke regarding the UDW labor negotiations with the County, and requested support of a wage increase and benefits for IHSS employees.

- *B3 Authorized HSA to accept funding from the California Department of Health Services, Office of Family Planning Information and Education Program, for Teen Pregnancy Prevention Educational Services in Stanislaus County; and, authorized the HSA Managing Director, or her Designee, to sign and execute the contract – HSA 2004-456
- *B4 Approved contract with Medex Practice Solutions, Inc. for provider staffing of the HSA Urgent Care Center and authorized the HSA Managing Director, or her Designee, to sign the agreement with Medex Practice Solutions, Inc. – HSA 2004-457
- *B5 Approved the application and acceptance of \$15,000 Challenge Activities funding; adopted the resolution, as required by the State Board of Corrections, authorizing the Chief Probation Officer to submit and/or sign Stanislaus County's application for approval of the County's Multiagency Juvenile Justice Plan Modification and related contracts, amendments, or extensions as approved by Juvenile Justice Coordinating Council – Probation 2004-458
- *B6 Authorized the Chief Probation Officer to apply for and accept a \$66,828 Juvenile Accountability Grant (2004) from the Board of Corrections to provide services and activities to assist youthful offenders in curbing their criminal behaviors; authorized the Chief Probation Officer to sign the grant award on behalf of the Board of Supervisors; and, authorized the Chief Probation Officer to negotiate and enter into agreements related to this grant – Probation 2004-459

- ***B7** Approved the agreement between the 38th District Fair Board and the Sheriff to provide security for the 2004 Stanislaus County Fair and authorized the Sheriff to sign the agreement – Sheriff 2004-460
- ***B8** Authorized the Sheriff to apply for two Officers in the Schools COPS Grant through the Federal COPS Office and authorized the Sheriff to enter into a partnership agreement with Waterford High School, Hart-Ransom Union Elementary, Spratling Middle School, Tuolumne School and Chatom Union School Districts – Sheriff 2004-461
- ***B9** Authorized the Sheriff to apply for and accept a \$247,312 Federal Bureau of Justice Assistance (BJA) Grant for the Stanislaus County Meth Gang Enforcement Project to combat large-scale manufacturing and distribution of methamphetamine; and directed the Auditor-Controller to increase Appropriations and Estimated Revenue in FY 2004/05 and carry over unused funds at the end of the fiscal year – Sheriff 2004-462
- ***C1** Approved Amendment No. 1 to Project Agreement No. 2003-02 with Kleinfelder, Inc., for environmental monitoring at the closed Geer Road Landfill for an amount not to exceed \$35,754; authorized the Chairman to execute the amendment to the agreement; and, directed the Auditor-Controller to increase Appropriations and Estimated Revenue by \$15,754 for environmental monitoring at the closed Geer Road Landfill – PW 2004-463
- ***C2** Approved a temporary service agreement for the performance of building inspection services between the City of Hughson and Stanislaus County; service to begin on 5/5/04 and shall continue until 6/30/04 when it shall automatically terminate; authorized the Chairman to execute the temporary service agreement for the performance of building inspection services as submitted; and, authorized the Director of the Department of Public Works to approve extensions of the term of the agreement and modifications to the agreement as appropriate – PW 2004-464
- ***C3** Approved Plans and Specifications for the 2004 County AC Overlay Project; directed the Clerk of the Board to publish the notice inviting bids for the program as required by law, and set the deadline for submission of bids as 7/21/04 at 2:00 p.m., directed the Public Works staff to mail notice inviting bids to trade journals as required by law; and, directed the Auditor-Controller to increase Appropriations by \$5,000 and Estimated Revenue by \$378,638 in the project account to defray the cost of advertising and publishing - PW 2004-465

Grover/Paul unan. **6:35pm** Conducted a public hearing to receive comments regarding the 2004/05 Annual Assessments and the assessment ballot process for the proposed increase in the annual assessments for CSA No. 10 – Salida; finds that the notice of the public hearing was given pursuant to Government Code §53753(B), Streets and Highways Code §22552, and Streets and Highways Code §22588; authorized the Clerk of the Board to oversee the tabulation of ballots and submit the results to the Board of Supervisors at the next scheduled meeting on 6/22/04; made the Annual Engineer’s Report Option “B” a part of the record of this proceeding; approved Staff Recommendations Nos. 1, 2, 3, and 6 in the staff report to the Board; and, **amended** the item to continue the levying of the assessment (Staff Recommendations Nos. 4 and 5) to the 6/22/04 meeting 2004-468

Simon/Paul unan. **6:40pm** Accepted the recommended Proposed Budget for FY 2004-2005 from the Interim CEO; conducted the scheduled public hearing at 6:40 p.m. on 6/15/04; authorized the Interim CEO and the Auditor-Controller to make the necessary technical adjustments to implement the approved Proposed Budget; denied an adjustment to Supervisors' compensation in accordance with the Stanislaus County Code Subsection D of Section 2.04.030, and the Board will not accept their December 2004 COLAs; amended the Salary and Position Allocation Resolution to reflect the recommended changes in the Proposed Budget, which provides for classification changes (as outlined in the staffing impacts of this report) to be effective on the first pay period beginning after 7/1/04, with the exception of the reductions-in-force which will be effective on 8/7/04; approved the reduction-in-force of twelve filled positions effective 8/7/04 as outlined on Attachment "A"; directed the Interim CEO to prepare the Final Budget and set the public hearing for consideration of the Final Budget at 9:30 a.m. on 9/14/04; directed the Interim CEO to review the possible sale of any surplus County property and include recommendations in the Final Budget; established a Special Board Committee to examine options to secure stable funding for public protection services; approved the establishment of the first phase of a General Services Agency Department as recommended in this report; **amended** the recommendations to approve the transfer of funds from Appropriations for Contingencies to the Veteran Services budget to restore the Friday office hours; and, **revised** the Salary and Position Allocation Resolution and Attachment "A" to allow one Psychiatric Nurse II (Position No. 10714) to remain on the list and not be deleted 2004-469

Corr 1 Accepted a letter from Kevin Williams, Director of DER and Parks and Recreation, announcing his resignation as the Director of these departments effective 6/22/04 to take a position with OES.

Corr 2 Referred to the Agricultural Commissioner and DER a notice from the California Regional Water Quality Control Board Central Valley Region regarding a conditional waiver of waste discharge requirements for discharges from irrigated lands in the Central Valley.
