Supervisor Mayfield met with the San Joaquin Valley Unified Pollution Control District regarding SB700 which impacts all indirect sources including the farming industry. The largest source of air pollution is still the mobile source.

The Chairman asked for an update regarding the Ag Pavilion efforts. The Interim CEO said that a report will be brought back to the Board sometime in the near future. She noted that the CEO staff has been meeting with the Ag Pavilion Steering Committee.

Dennis Gudgel, Agricultural Commissioner, spoke on the recent capture of a fruit fly in Stanislaus County. The Ag Commissioner's office and additional governmental agencies immediately began to put out additional traps in an 81 square mile area in efforts to find any additional flies. One fly can lay a thousand eggs within their 18-day life. If additional flies are found Stanislaus County will become a quarantine area. No additional flies have been found as of yet. The traps will be monitored through the month of September. The Agricultural Commissioners' office has an Insect Trapping program but this program is in jeopardy because of the State's budget crisis. He noted that the eradication program for the Fruit Fly is a relativity easy program.

The Interim CEO updated the Board regarding the State Budget impasse. The core issue of the impasse is that portions of the State Legislature want to have the ability to raid the local cities and counties coffers when the State needs funds. The State wants the ability to take additional funds from city and counties on top of what they have already taken. In Stanislaus County it means that besides the \$8.5 million lost in FY 2003/04, the \$4.5 million we will not receive in FY 2004/05 and another \$4.5 million next fiscal year, the State can take additional funds.
