Simon/O'Brien unan. **9:25 a.m. (VI-E)** Adopted the \$2.436 million 2005/2006 Fiscal Year Budget and authorized staff to take all necessary steps to implement the 2005/2006 Budget 2005-269

Simon/O'Brien unan. 9:30am Based on testimony received, staff report, materials provided to the Board, and Board comments, the Board denied the appeal and upheld the Planning Commission's decision of denial of Use Permit Application #2004-29, D.B. Truck Body Parking, a request to operate a secured truck and trailer parking lot for up to 23 trucks on the site of an existing agricultural repair service (Use Permit #2003-36) on approximately 3.5 to 4± acres of a 10.12± acre property located in the A-2-40 (General Agriculture) zoning district at 4125 Beckwith Road in the Modesto/Salida area; the Board finds that the evidence indicates that this business does not meet the Zoning Ordinance definition, nor the intent of the Ordinance Code, to be considered an agricultural service establishment, this is based upon the fact that a significant amount of the business involves working on vehicles which clearly are not agricultural in nature; finds that there is not sufficient evidence to allow the Board to establish that all of the required use permit findings, as contained in the staff report to the Board can be made; specifically, the Board finds it is not "necessary and desirable" that this business be located in the A-2-40 zoning district; and, denied Use Permit Application #2004-29 due to the inability to be able to make all of the findings required to grant approval of the permit and because it does not meet criteria to be an agricultural service establishment – Planning 2005-270

Chairman Grover noted that at the next LAFCO meeting, the two Board member representatives would need to abstain due to a conflict of interest, and the Alternate Member will be out of town. He asked County Counsel what options the Board has to ensure that they have representation at this meeting. County Counsel responded that he will research this issue and bring recommendations back to the Board next week.

Supervisor DeMartini spoke regarding the defeat of SB 453, which would have restored the funding and ensured continuation of the Central Valley Rural Crime Prevention Program. He noted that this has been a successful program and that it is unfortunate that this bill was defeated.
