Bruce Ramsey, President of the Law Library Board of Trustees, presented a resolution and plaque to the family of James J. Milam.

The Chairman presented a resolution proclaiming April as Child Abuse Prevention Month and April 22, 2005 as Children's Memorial Day in Stanislaus County.

Sheree Howell spoke in support of AB 19, the Religious Freedom and Civil Marriage Protection Act.

Nina Perez also spoke in support of AB 19 and stated that it would provide stability for gay and lesbian families.

Jeff Gianelli provided information to the Board regarding AB 19, and spoke in support of this Act.

Simon/DeMartini (3-2)(O'Brien and Mayfield opposed) 7:00 pm Based upon the testimony received, staff report and attachments, staff presentation and Board discussion, the Board granted the appeal of Planning Commission's denial and approved Use Permit Application #2003-35, Gurdwara Sant Sagar Church located on property at 3418 Golf Road, south of Turlock; project includes a 4,800 sq. ft. temple and 188 paved parking spaces in the A-2 zoning district subject to the Conditions of Approval; finds the project to be De Minimis for the purposes of collection of Fish and Game Fees pursuant to California Code of Regulations §753.5, by adopting the findings of fact contained in the attached Certificate of Fee Exemption, those findings being based on the analyses presented in the Initial Study; ordered the filing of the Certificate of Fee Exemption with the Stanislaus County Clerk-Recorder's Office; adopted the Mitigated Negative Declaration pursuant to CEQA Guidelines §15074(b), by finding that on the basis of the whole record, including the Initial Study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Mitigated Negative Declaration reflects Stanislaus County's independent judgment and analysis; ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorder's Office pursuant to Public Resources Code \$21152 and CEOA Guidelines \$15075; finds that: (A) the establishment, maintenance, and operation of the proposed use or building applied for is consistent with the General Plan designation of General Agriculture and will not, under the circumstances of the particular case, be detrimental to the health, safety, and general welfare of persons residing or working in the neighborhood of the use and that it will not be detrimental or injurious to property and improvements in the neighborhood or to the general welfare of the County; certain conditions have been added to ensure that the impact from this project is minimal, (B) the establishment as proposed will not be substantially detrimental to or in conflict with agricultural uses of other property in the vicinity, (C) the parcel on which such use is requested is not located in one of the County's "most productive agricultural areas," as that term is used in the Agricultural Element of the General Plan; or the character of the use that is requested is such that the land may reasonably be returned to agricultural use in the future, (D) the project will increase activities in and around the project area, and increase demands for roads and services, thereby requiring dedication and improvements; approved Use Permit Application 2003-35 - Gurdwara Sant Sagar Church, subject to the Conditions of Approval – Planning 2005-298

Supervisor O'Brien spoke regarding SB 1334 and the removal of oak woodlands. He noted the importance of oak trees, especially on the East Side of the County. Recently, a number of oak trees were knocked down on a parcel outside the Oakdale City limits, but within their sphere of influence. He suggested that the County look at the City of Oakdale's ordinance regarding the removal of oak trees, and consider adopting a similar one.

Supervisor DeMartini noted that tomorrow he will present a check in the amount of \$129,000 to the City-County Airport for infrastructure improvements. This is the County's share of property tax assessments for aircraft.

CEO noted that tomorrow the Senate Local Government Committee would be hearing SB 9 concerning the Peterson trial reimbursement. District Attorney Jim Brazelton, Assistant Sheriff Mark Puthuff, Deputy Executive Officer Richard Jantz, and Don Peterson, our legislative representative, will be testifying at this hearing tomorrow. He also reported that there would be an intensive 2-day retreat on 4/20/05 and 4/21/05 as the next step in studying the HSA deficit.
