Supervisor Mayfield requested that an item be returned to the Board to address a pig farm on Esmar Avenue in Ceres and the Agape House on the same road. He also spoke about an article in the Modesto Bee regarding cows and air pollution. He noted that he will be asking the San Joaquin Air Pollution Control District to address this issue, and requested support from the Board of Supervisors.

The CEO said he would work with Counsel regarding bringing the items requested by Supervisor Mayfield back to the Board.

Supervisor DeMartini supported Supervisor Mayfield's position regarding agriculture and air pollution. He also spoke about his concerns for County vehicles that were used for a 5.1.1. Tactical, Inc. advertisement, and the need for a County policy prohibiting this type of activity.

Supervisor O'Brien voiced his concern regarding the number of investigations that are being conducted in the County. Supervisor Simon acknowledged Supervisor O'Brien's comments, and noted that these types of investigations are common in County government.

Chairman Grover asked Counsel how long the county has, to respond formally to Grand Jury reports. County Counsel Mick Krausnick responded that the County and its departments have 90 days to respond, and elected officials that are subject to investigation have 60 days to respond. Supervisor Mayfield asked that the responses be returned to the Board three weeks before they are due.

The CEO reported that staff's goal is to have the responses to the Grand Jury reports to the Board on 8/23/05, with a fall back date of 9/13/05. He also indicated that he is still working on the reply to the ICJIS inquiry and hopes to complete it within 2-3 weeks.
