Corr 3 Referred to the Chief Executive Officer, the Department of Planning and Community Development, the Department of Public Works, the Department of Environmental Resources, County Counsel, and the Agricultural Commissioner and Sealer of Weights and Measures, a letter from the City of Modesto regarding the proposed Regional Water Treatment Plant Site which is subject to Williamson Act Contract within an Agricultural Preserve.

Corr 4 Acknowledged receipt of claims and referred to the CEO-Risk Management Division the following claims: Michael Brown; Kenneth Grays; and, Luanne Bain.

Supervisor DeMartini reported on the trip that he, Chairman Grover, Bill Basset, the Hispanic Chamber of Commerce, and CSUS, took to Monterey, Mexico last week to encourage companies there to do business in Stanislaus County. He noted that former County Supervisor Nick Blom is doing well recovering from his cancer surgery.

The CEO announced that Terry Plett, Director of DET, plans on retiring effective 12/2/05. He gave an update regarding meetings with DMC about the transition to a new health care delivery model in the clinic system, and noted that he is hopeful that they will find a mutually agreeable solution to the issues that have been raised. The CEO reported that his office is working with the Federal lobbyist Patton Boggs to address SBHC funding issues and to seek long-term solutions.
