Supervisor Grover represented the Board at the Waste to Energy Executive Committee meeting on Thursday. He, along with Supervisors DeMartini and O'Brien, attended the StanCOG meeting on Wednesday night. He noted that the Modesto Bee article on 12/16/06 concerning water issues was inaccurate.

Supervisor DeMartini reported that the Steering Committee for the Crows Landing Naval Air Base Development will be meeting on 1/17/07 with two developers that have made formal proposals.
