Corr 2 Referred to the Alliance Worknet, and the Stanislaus Economic Development and Workforce Alliance, a letter from Indalex Aluminum Solutions updating their plans to discontinue and close their Modesto facility located on 4555 North Star Way, Modesto, CA 95356, the termination of employees is expected to take place beginning 07/18/08, per the Worker Adjustment and Retraining Notification (WARN) Act.

Corr 3 Referred to the CEO, a letter from Children and Families Commission requesting opposition to SBX3 16 (Cox) and other any legislation that would divert Proposition 10 resources and/or remove local control of how the resources are used in Stanislaus County.

Corr 4 Referred to HSA and DER, a letter from the Turlock Mosquito Abatement District regarding the West Nile virus and the control of the mosquitoes in Stanislaus County.

Corr 5 Referred to the CEO and HSA, a letter from Save Our Society From Drugs (SOS) requesting that the Board reject needle exchange programs in our community.

Corr 6 Referred to the CEO, a letter from J.S. West and Companies requesting opposition to Proposition No. 2 “Treatment of Farm Animals Statute” which will appear on the November 4, 2008 ballot.

Corr 7 Referred to the CEO, a letter from Californians Against Waste requesting support for SB 1625 (Corbett) regarding expanding California’s Recycling Law to include all plastic bottles.

Corr 8 Acknowledged receipt of claims and referred to the CEO-Risk Management Division the following claims: Clark & Sullivan Builders, Inc. (W.F. Hayward Co. indemnity); Clark & Sullivan Builders, Inc. (Collins Electrical indemnity); Jolene Wyrick; Cindy Wilson; Judy K. Mitchell; Steven A. White; and, Bob Burke.

Supervisor DeMartini commented that SBX3 16 (Cox) is another attempt by the State of California to steal money from cities and counties. He recommends that the Board oppose this bill. Supervisor Monteith also spoke regarding this bill and other attempts by the State to take money away from local government.

The Assistant CEO gave an update regarding the activities of OES during the heat incident that occurred last week, as well as their continued involvement in providing fire fighters and resources statewide to assist with the wildfires. She reported that Senator Feinstein is recommending a federal budget appropriation of \$400,000 for the Orestimba Creek Flood Control Project. She also reported that the State budget situation is worsening, and that there are discussions at the State level regarding balancing the State budget by withholding local funds under the provisions of Prop 1A. Funds for Prop 10 Families First, Prop 42 Transportation and Prop 63 Mental Health Act are also at risk. This would be a significant loss to local government. She noted that County staff will continue to stay vigilant in watching the State budget issue, and will keep the Board updated.
