Supervisor DeMartini voiced his opposition to Proposition 2 as it will have a negative impact on agricultural economy especially to the poultry industry in Stanislaus County. He request the Board to oppose this initiative.

The CEO spoke regarding Proposition 2 saying that this proposition potentially could negatively impact Stanislaus County. He noted that the State Senate has been called into session and that a vote on the budget was expected in the Senate today. Letters were sent to our State legislative members opposing the State taking funds from Proposition 1A; 10; and, 42 that normally went to Counties. He thanked Modesto Bee reporter Tim Moran on his excellent article in today's newspaper regarding the challenges Stanislaus County is facing because of the State budget crisis.
