Vice-Chairman DeMartini gave a report on the work done by the Westside Healthcare Task Force, a coalition made of Stanislaus County, Merced County, three hospitals, two healthcare districts, three cities and healthcare providers, which are working to improve healthcare on the West Side. He thanked County staff, including the CEO-Economic Development Unit and County Counsel for their help with this taskforce.

The CEO reflected on the Year 2008 and expressed his appreciation to the Board for their leadership during these very difficult times. He reminded the public that most County offices will be closed on 12/26/08 and 01/02/09. He reported that the State Assembly and Senate are meeting concerning the State Budget deficit, and that there has not been much progress yet. He will keep the Board updated regarding the State Budget situation.

Supervisor Grover spoke regarding Ryan Dickerson and announced that there will be a dedication of the Ryan Hunter Dickerson Reading Tree in his memory on Tuesday, 12/30/08 at 3:30 p.m., at the Stanislaus County Modesto Library Children's Room, located at 1500 I Street, Modesto.
