Chiesa/Grover unan. 9:15 a.m. Based upon the staff report, presentations by staff and reports of consultants, including the PowerPoint presentation, all comments and testimony received during the public hearing, and all materials that were supplied to the Board and were taken into consideration in its decision, the Board denied the appeal and upheld the Planning Commission's decision to approve Use Permit Application No. 2008-03 - Delaney Aggregates, and specifically adopted Staff Recommendations Nos. 1 through 7 on pages 2 and 3 of the staff report as follows: 1) adopted the Mitigated Negative Declaration pursuant to CEQA Guidelines §15074(b), by finding that on the basis of the whole record, including the Initial Study and any comments received, that there is no substantial evidence the project will have a significant effect on the environment and that the Mitigated Negative Declaration reflects Stanislaus County's independent judgment and analysis; 2) made the following required findings for approval: (A) the establishment, maintenance, and operation of the proposed use or building applied for is consistent with the General Plan designation of "Agriculture" and will not, under the circumstances of the particular case, be detrimental to the health, safety, and general welfare of persons residing or working in the neighborhood of the use and that it will not be detrimental or injurious to property and improvements in the neighborhood or to the general welfare of the County; (B) the use as proposed will not be substantially detrimental to or in conflict with agricultural use of other property in the vicinity; (C) the parcel on which such use is requested is not located in one of the County's "most productive agricultural areas," as the term is used in the Agricultural Element of the General Plan, or the character of the use that is requested is such that the land may reasonably be returned to agricultural use in the future; (D) the

alternative to the Agricultural Buffer Standards applied to this project provides equal or greater protection than the existing buffer standards; (E) the use will not significantly compromise the long-term productive agricultural capability of the subject contracted parcel or parcels or on other contracted lands in the A-2 zoning district; (F) the use will not significantly displace or impair current or reasonably foreseeable agricultural operations on the subject contracted parcel or parcels may be deemed compatible if they relate directly to the production of commercial agricultural product on the subject contracted parcel or parcels or neighboring lands, including activities such as harvesting, processing, or shipping; (G) the use will not result in the significant removal of adjacent contracted land from agricultural or open-space use; (H) the project complies with the provisions of the Surface Mine and Reclamation Act (SMARA) and State regulations; (I) the final approved Reclamation Plan: (i) complies with SMARA §2772 and 2773, and any other applicable provisions; (ii) complies with applicable requirements of State regulations (CCR \$3500-3505, and \$3700-3713); (iii) is consistent with County Zoning Code Chapter 21.88 (Surface Mining and Reclamation) and the County's General Plan and any applicable resource plan or element; (iv) has been reviewed pursuant to CEQA and the County's environmental review guidelines, and all significant adverse impacts from reclamation of the surface mining operations are mitigated to the maximum extent feasible; (v) restores land and/or resources such as water bodies to be reclaimed to a condition that is compatible with, and blends in with, the surrounding natural environments, topography, and other resources, or that suitable off-site development will compensate for related disturbance to resource values; (vi) restores mined lands to a usable condition which is readily adaptable for alternative land uses consistent with the General Plan and applicable resource plan; and, (vii) a written response has been prepared to the State Department of Conservation, describing the disposition of major issues raised by the Department and that where the County's position is at variance with the recommendations and objections raised by the State Department of Conservation, said response shall address, in detail why specific comments and suggestions were not accepted; 3) ordered the filing of a Notice of Determination with the Stanislaus County Clerk-Recorders Office pursuant to California Public Resources Code §21152 and CEQA Guidelines §15075; 4) approved Use Permit Application No. 2008-03 - Delaney Aggregates, subject to the attached Conditions of Approval and Mitigation Measures; 5) approved the attached Reclamation Plan for Use Permit Application No. 2008-03 - Delaney Aggregates, subject to compliance with the Conditions of Approval and Mitigation Measures; 6) ordered the filing of a Notice of Reclamation Plan Approval with the Stanislaus County Clerk-Recorders Office pursuant to the California Public Resources Code §2772.7.; and, 7) approved the proposed Financial Assurance for Use Permit Application No. 2008-03 - Delaney Aggregates, in accordance with California Public Resources Code §2770 – Planning 2009-204

Grover/Monteith unan. **B10** Acknowledged the award for up to \$18 million from the State of California, Corrections Standards Authority and directed County staff to negotiate a contract with the State to build the Juvenile Youth Treatment Facility (YTF) with funds under the Department of Corrections 2007 Local Youthful Offender Rehabilitative Facility Construction Funding Program (SB81); authorized the release of Requests for Proposals (RFP's) for professional services such as Architect, Surveyor, Soils Engineer, Phase I Environmental and the required Property Appraisal; approved the Juvenile Justice Facilities Master Plan created as collaboration between the CEO, Probation Department, and consultant, Daniel C. Smith & Associates, Inc.; directed the Auditor-Controller to increase appropriations and estimated revenue in the Juvenile Hall Commitment Facility Capital Project's budget by \$2,179,980, to fund the cost of the planning and design phase and authorized the Auditor-Controller to increase appropriations by \$699,724 in the Youthful Offender Block Grant fund, and to transfer \$699,724 into the project budget from the Youthful Offender Block Grant for this phase of the project, as detailed in the Budget Journal

form; and, authorized the Project Manager to negotiate and sign contracts, work authorizations, and purchase orders for professional services needed in this phase of the project on behalf of the Board as long as they are within the project budget and staff will return to the Board for approval of the contract for the design work as well as the recommended contract with the State – CEO 2009-202

Grover/O'Brien unan. **B11** Accepted a report from the Agricultural Advisory Board on the use of tertiary wastewater for Agricultural Purposes – Agricultural Commissioner/Agricultural Advisory Board 2009-203

Corr 1 Referred to the Department of Planning and Community Development, a letter from the U.S. Department of Housing and Urban Development regarding the awarding of \$9,744,482 to Stanislaus County for the action plan amendment for the Neighborhood Stabilization Program (NSP).

Corr 2 Referred to the Agricultural Commission/Sealer of Weights and Measures; University of California Cooperative Extension; and the Department of Planning and Community Development, a letter from the California Natural Resources Agency regarding a petition for change to consolidate the State Water Project, Central Valley Project and Friant authorized places of use.

Corr 3 Acknowledged receipt of claims and referred to the CEO-Risk Management Division the following claims: Alexander D. Gevarges and Fred L. Winters.

Supervisor Grover reported that he and Supervisor Chiesa went to see a garden project on Friday afternoon in which young people from the west side of Modesto are introduced to gardening on land owned by the Heifer Project. The produce from the garden will be sold on Thursday afternoons in Mellis Park at the Farmers Market. He noted that it is a good example of positive mentorship and what the community is working on.

Chairman DeMartini reported that the second meeting of the Westley Triangle Business Owners was held last night. He thanked the Public Works Department for their help in putting this meeting together. This group is developing a plan for landscape, lighting and road improvements to attract more business in the Westley area. These improvements will be funded 100% by the business owners. He also noted that he and Supervisor Chiesa will be going out with the Probation Department this afternoon to see the new drug sniffing dog in action.

The CEO reported that the \$9.6 million check to DMC was delivered on Friday afternoon and that County staff is continuing to work with Tenant Corp and our federal representatives in structuring a solution for the Physician Residency Program. He reported that the State did not reach the "trigger" level of federal funds needed to avoid an additional \$1.8 billion in State taxes and \$948 million in program cuts. He believes that we have already seen the worst of the local government cuts.
