Pledge of Allegiance to the Flag

The Chairman presented resolutions proclaiming May 2009 as Older Americans Month and Elder Abuse Prevention Month.

Maggie Meja from the Latino Community Roundtable asked the Board for information concerning Swine Flu. She invited the Board members to the Cinco de Mayo Parade being held on Crows Landing Road on Saturday 05/02/09 and the Cinco de Mayo Fiesta being held in Tuolumne Park on Sunday, 05/03/2009.

Ricardo Cardenas from the Crows Landing Road Business Association thanked the Board and the Sheriff's Department for their support. He spoke regarding the Día de Niño event being held this Thursday at 1700 Crows Landing Road.

The CEO thanked Maggie Meja, the Sheriff's Department and the Public Works Department for their work in making the Cinco de Mayo event happen. He gave an update regarding the distribution of information regarding Swine Flu, and noted that the County is actively engaged in sharing information with the Latino community.

Dr. Walker, County Health Officer, gave an update regarding the County's efforts in addressing Swine Flu. He reported that an English/Spanish information page and poster was distributed yesterday throughout the community. He noted that Public Health has activated the flu hotline, and is posting information on the OES website: stanemergency.com.

- \*B8** Approved the distribution of excess proceeds of \$124,111.76 from the 02/27/08 sale of tax defaulted properties; and, authorized the Auditor’s Office to issue checks totaling \$124,111.76 per the list of claims for excess proceeds submitted in accordance with Revenue and Taxation Code §4675 – T/TC 2009-269
- \*B9** Authorized the Director of DER and Parks and Recreation, or her Designee, to submit an Application for American Recovery and Reinvestment Act of 2009 funds for diesel emissions reductions – DER 2009-270

**\*D1** Rescinded all of Williamson Act Contract No. 1971-0009 and a portion of Williamson Act Contract No. 1972-0771, (Yosemite Blvd., southeast of La Grange) and authorized the Planning Director to execute new contracts pursuant to Minor Lot Line Adjustment 2008-32 – Rodden-Coleman; finds the new contracts would enforceably restrict the adjusted boundaries of the parcel for an initial term for at least as long as the unexpired term of the rescinded contract or contracts, but for not less than 10 years; finds there is no net decrease in the amount of the acreage restricted. In cases where two parcels involved in a lot line adjustment are both subject to contracts rescinded pursuant to this section, this finding will be satisfied if the aggregate acreage of the land restricted by the new contracts is at least as great as the aggregate acreage restricted by the rescinded contracts; finds at least 90 percent of the land under the former contract or contracts remains under the new contract or contracts; finds after the lot line adjustment, the parcels of land subject to contract will be large enough to sustain their agricultural use, as defined in Section 51222; finds the lot line adjustment would not compromise the long-term agricultural productivity of the parcel or other agricultural lands subject to a contract or contracts; finds the lot line adjustment is not likely to result in the removal of adjacent land from agricultural use; and, finds the lot line adjustment does not result in a greater number of developable parcels than existed prior to the adjustment, or an adjusted lot that is inconsistent with the general plan –

The CEO gave a report regarding CSAC's opposition to AB 155 (Mendoza), and noted that he has prepared a letter of opposition for the Chairman to sign. He also gave an update regarding the County's activities in addressing the Swine Flu and reported that a Threat Assessment Group (TAG) meeting was held on Friday made up of representatives of OES, Public Health, the medical community, education, local cities, agriculture and law enforcement. The next TAG meeting will be held on Friday 05/01/2009. He noted that no cases of Swine Flu have been identified in Stanislaus County. A Stan MAC (Multi-Agency Coordinating Council) meeting has been scheduled for today to establish an action plan in the event that Swine Flu does reach our community.
