- *B1 Approved the reduction-in-force of one filled full-time position in the County Fire Service Fund budget as outlined in the Staffing Impacts effective 01/16/2010; and, amended the Salary and Position Allocation Resolution to reflect the changes as outlined in the Staffing Impacts section of the agenda item effective 01/16/2010 – OES 2009-825
- *B2 Authorized the Director of DER, or her Designee, to accept groundwater protection contract funds from the United States Environmental Protection Agency to implement the Underground Injection Control Program – DER 2009-826
- *B3 Approved amending the agreement with the Radio Control Flyers Unlimited Inc., for the continued use, operation, and maintenance of the landing strip and field area at Woodward Reservoir from 01/01/2010 through 06/30/2010; and, authorized the Director of Parks and Recreation to sign the amendment to extend the term of the contract from 01/01/2010 through 06/30/2010, upon mutual agreement with the Radio Control Flyers Unlimited Inc. – Parks and Recreation 2009-827

The CEO reported that Don Peterson, Stanislaus County's Legislative Advocate, and a good friend of local government, passed away after a prolonged battle with cancer. CEO Robinson gave a federal legislative update and noted that the Omnibus Bill passed, which includes \$360,000 for the Tuolumne River Regional Park, and \$300,000 for the Interoperability Program. He also noted that the Energy and Water Bill that was previously approved included an allocation of \$341,000 for the Orestimba Creek Project. Stanislaus County has had a successful year in regards to federal earmarks.
