\*B1 Approved the allocation for Highway Property Rental Revenue of \$18,895.16; allocated \$8,206.75 for the payment of possessory interest tax bill (ASMT 860-000-576) in accordance with California Streets and Highways Code §104.13 (C); allocated \$1,830.00 of lease revenue to the City of Modesto in accordance with California Streets and Highways Code §104.10; and, allocated \$8,858.41 of lease revenue to the County Road Fund, in accordance with the provision in California Streets and Highways Code §104.10, that its spending be limited to mass transit or streets and highway purposes – Auditor-Controller 2011-138

\*B2 Authorized the Chief Probation Officer to apply for and accept, if awarded, an Alcohol and Other Drugs Grant from the State Office of Traffic Safety for enhanced felony drunk driver probation supervision services, and to sign all necessary documents including all contracts – Probation 2011-139

\*B3 Authorized the Chief Probation Officer to apply for and accept, if awarded, a Probation and Court-Based Alternatives (PCBA) Project Grant from the California Department of Corrections and Rehabilitation, Corrections Standards Authority to reduce the number of non-violent female youth in secure detention for violations of probation, failures to appear in court and bench warrants; and, adopted a resolution authorizing the Chief Probation Officer to submit the application for the PCBA Project and sign all necessary documents related to the grant, including all contracts – Probation 2011-140

\*C1 Authorized the Director of Public Works to accept deeds or grants for public purposes and consent to the recording thereof pursuant to Government Code §27281; and, ratified the Certificates of Acceptance and Consent to Record for the deeds listed in Exhibit "A" – PW 2011-141

\*C2 Adopted the results of the assessment ballot procedure that proposed a new assessment methodology for the North McHenry No.1 Lighting District (weighted Supporting votes: 102.153; weighted Protest votes: 149.149; and weighted Incomplete ballots: 28.298); declared that a simple majority of the assessment ballots received protested the proposed method for calculating the annual assessment; and, authorized the Public Works Department to implement a 5-year plan effective 03/09/2011, to recover the District's deficit by turning off streetlights within the District to lower expenses below assessment revenue and to leave the streetlights off until the deficit is eliminated – PW
