The CEO reported that the State is on the verge of a majority vote for the Budget, possibly as early as today. He noted the significant aspects of the proposed budget including a \$9.6 billion budget year deficit, cutting \$150 million for the UC and CSU systems, a \$200 million Amazon tax (tax on purchases through Amazon.com), the deferral of \$2.8 billion to the K-12 and community college education, \$300 million projected from a \$12 increase in DMV registration fees, \$150 million increase in State revenue resulting from the establishment of a fire fee, \$1.7 billion in redevelopment funding to be redirected from Redevelopment Agencies to the State, and a projected \$1.2 billion increase in revenues for May and June. The Budget also projects \$4 billion in new revenue and establishes a number of triggers for additional budget cuts if this new revenue does not materialize. There are several items that were rejected that had originally been part of the proposed plan including \$112 billion from the sale of State buildings, \$900 million from a 25¢ sales tax, \$1 billion from the First Five Commission, \$500 million from local law enforcement, \$500 million from the UC system, and \$700 million in additional cuts to Medi-Cal programs. The CEO reported that there are still many uncertainties and unknowns, but it appears that the Democratic Legislature and Governor are in agreement in the overall nature of the proposed budget, and that the Bridge Tax will not be put in place. The Governor's proposal, endorsed by the leadership in the Senate and the Assembly, does fund the public safety realignment program. The CEO noted that this is preliminary information, and that the impact of this budget on local governments is not yet known.
