Emerson Drake spoke regarding election campaign reform and requested that the following changes be made: require a Board of Supervisors member to recuse themselves from a vote if they received a campaign contribution above a set limit, and prohibit elected officials from entering into a contract with a vendor who made contributions to their election campaign.
