Withrow/De Martini unan. **B5** In accordance with Employee Relations Ordinance 3.68.370 and Government Code §3505.4, approved implementing the provisions of the County's last, best, and final offer for healthcare benefits, as provided for in Attachment A, to Service Employees International Union (SEIU) representing the Community and Health Services Bargaining Unit – CEO 2011-714

O'Brien/Chiesa unan. **B6** Accepted the one year summary report of the Regional Transportation Impact Fee group; adopted a Resolution approving the preparation of a Nexus Study for the Regional Transportation Impact Fee program; and, authorized the use of Public Facilities Fees in the amount of \$10,713.90 for the preparation of a Regional Nexus Study – CEO 2011-715

County Counsel determined that Supervisors O'Brien, Chiesa, Withrow and De Martini have disqualifying conflicts of interest with agenda item **D-6** because they all own agricultural property under Williamson Act contract or qualified to be under contract. Therefore, in order to establish a quorum to consider this matter, the Board invoked the rule of necessity and Supervisor O'Brien and Supervisor De Martini drew long straws and thus participated in the decision.

De Martini/O'Brien (3-0)(Withrow and Chiesa abstained) **D6** Finds that the County received less than one-half of the foregone property tax revenue pursuant to Government Code §16142.1(d)(1) for the 2011-2012 Fiscal Year; approved the implementation of AB 1265 (Formerly SB 863) to maintain Williamson Act Contracts including a reduction of property tax benefits by ten percent and a related reduction of the term of the contracts to nine years, to be effective for calendar year 2012; and directed the Assessor, Auditor-Controller, Treasurer-Tax Collector, and Director of Planning and Community Development to take all necessary steps to implement AB 1265 for the 2012-2013 Fiscal Year including, but not limited to, making the appropriate modifications to all affected properties assessed values, modifying tax bills to

reflect the assessment changes and supplemental fees associated with the reduced tax benefit, and recording any necessary notices – Planning 2011-716

Supervisor De Martini noted that Supervisor O'Brien has a birthday this week. Supervisor De Martini served on the Observer Panel for the 11/08/11 Election and reported that the elections were run professionally and flawlessly, and that he found no irregularities with the procedure.

CEO Robinson reported that the State cash report has been in the news for the last 2 weeks. For the month of October, California was \$810.5 million behind in expected collections, or 16.3% down year-to-date, and personal income tax is down by approximately \$450 million. In addition, the State spent \$1.7 billion more than was anticipated for the first 4 months of the fiscal year. He reported that the Federal Continuing Resolution lasts through 11/18/11, and it is anticipated that Congress will approve a new Continuing Resolution.
